**April 2016 Report** 

### **CHIEF'S ACTIVITIES**

The following is a list of tasks/assignments/responsibilities carried out in the month of April 2016:

I attended bi-weekly meetings with other City of Tomah Department Supervisors.

As a board member of the Tomah Area Boys and Girls Club I attended board meetings and subcommittee meetings related to this organization.

I attended an Administrative Staff meeting with members of the Tomah Police Department.

I attended a meeting with CenturyLink to discuss the City Hall and Police Departments' phone system. At issue were several small items that needed to be fixed or taken care of to complete the project.

Several officers and myself met with the United Piecemakers quilting group. The group donated several quilts to the police department to hand out to those in need.

April is Child Abuse Prevention Month. I attended a Proclamation Signing event attended by many different organizations and citizens who are concerned about child abuse in Monroe County.

I attended a Monroe County Mental Health meeting held at the Tomah Memorial Hospital.

City Administrator Gorius, Mayor Patter, and I attended a Monroe County Tavern League meeting held at Callahan's bar. Several bar owners were on hand to ask questions of us.

I attended a Monroe County Coordinated Services Team meeting held at the Tomah Police Department. This is a program ran by the Monroe County Health Services designed to provide services to at risk youth.

I attended a Monroe County Safe Community Coalition meeting.

I attended a Monroe County Health Improvement/Assessment meeting to discuss long term goals and plans to improve health care in and around Monroe County.

I met with representatives from Communication Services to receive an update on our current radio project. Phase 1 or the radio project should be implemented by June 1, 2016.

### **OPERATIONS LIEUTENANTACTIVITIES**

The following is a list of tasks/assignments/responsibilities carried out in the month of April 2016 by Lieutenant Ron Waddell:

All scheduling responsibilities (time off, overtime, special events, etc.).

Facilitated responsibilities as a Time Agency Co- Coordinator (TAC), scheduling on-line recertification and conducting expiration audits. Task is shared with Lt. Scott Holum.

Many of my shifts require a dual role, working as shift supervisor and completing administrative responsibilities.

Provide assistance as needed with incoming temporary evidence as needed. The evidence responsibilities may require return of evidence and limited destruction of evidence as time permitted. Evidence is provided to officers for follow-up and/or turn over to other police agencies.

Review of all "Use of Force Reports".

Received, processed, and scheduled "Ride Along Requests" that were approved for civilians.

### SUPPORT SERVICES LIEUTENANT ACTIVITIES

The following is a list of tasks/assignments/responsibilities carried out by Lieutenant Scott Holum in April of 2016:

I conducted Shift Supervisor responsibilities on some of my shifts.

I monitored the Prescription Drug Box in the front lobby of the police department. Collected medications will be dropped off at a collection site on May 2, 2016.

I started a new hiring process for the vacant patrol officer position.

I attended an Administrative Staff meeting.

Sergeant Preuss and I processed all incoming evidence.

I continued to research cases and purge property in the evidence storage area.

I commanded the Field Training program that is supervised by Sergeant Pedersen. Officer Rylan Corcoran and Officer Brandon Kuhn are both currently in Step V (Solo patrol) and are performing well.

I provided oversight to Sergeant Huneck and Sergeant Jones concerning the Fleet Maintenance program with scheduled and unscheduled repairs.

I assisted Lt. Waddell in scheduling related matters.

I performed the duties as the department's Time Agency Coordinator (TAC).

### COMBINED TACTICAL UNIT

### COMBINED TACTICAL UNIT CALL OUT:

April 20 – Search Warrant. Monroe County Joint Investigative Task Force (MCJITF) requested assistance with serving a search warrant in Sparta. Based on the threat assessment and the residence to be searched a partial team call out was authorized. CTU and MCJITF personnel met at the Sparta Police Department for a briefing and developed a plan to serve the search warrant. CTU personnel, including Sparta Police Department K-9, went to the location and knocked and announced at the front door to the residence. After approximately 45 seconds and no response from inside CTU personnel breached the door and entered the residence. Two people inside were detained without incident and the remainder of the residence was searched for people with no one else being found inside.

### TRAINING REVIEW:

April 19 – Training was conducted at Fort McCoy and consisted of a classroom presentation and then hands on training with AMTRAK. CTU was fortunate to receive approval from AMTRAK to conduct this training in our area due to the costs associated, which are completely covered by AMTRAK. In the morning AMTRAK and CP Rail personnel delivered a presentation on general railroad safety for first responders and also provided SWAT specific information on their equipment. In the afternoon we had the opportunity to conduct hands-on training with a AMTRAK car including removing windows and using ladders to conduct second level entries. La Crosse Police Department Emergency Response Team accepted an invitation to attend the training with us. Fort McCoy Fire Department coordinated training for area fire and EMS personnel on the two days following the SWAT training day.

Concern about student making suicidal comments. Student then left school. Contact with parent who was made aware of the comments and was in contact with the student.

Spoke with Intake Worker from Monroe County Human Services.

Patrol officers assisted with taking a student into custody for Monroe County Human Services.

Spoke with a student about their inappropriate behavior during class and towards a substitute and that it could result in disorderly conduct.

### INVESTIGATIONS

# [16-0540] Burglary, Criminal Damage to Property, Possession of Burglarious Tools, Bail Jumping, Probation/Parole Hold

Tomah officers were dispatched to Microtel for a report of a male subject going through vehicles. The subject was located as he was walking away from a shed. The subject had a set of bolt cutters in his hand at the time of his detention. The subject was asked what he was doing and he commented, "Trying to break into that shed." The lock and hasp on the door had been cut and the subject stated he did the damage. The subject was taken into custody and probation was contacted. Probation placed a hold on the subject and he was transported to the Monroe County Jail and booked on charges related to the crimes he committed.

### [16-0561] Disorderly Conduct-Alcohol Related

Tomah officers were dispatched to an address on Butts Avenue for a disturbance complaint. Officers learned the victim had been at Callahan's Bar and was confronted by two male subjects. The two male subjects confronted the victim in the beer garden area. One of the suspects used a shovel to cover the surveillance camera while the other punched the victim. The victim claimed the two suspects were accusing him of being a pedophile. Both suspects eventually admitted to creating the disturbance. Both suspects were issued municipal citations for Disorderly Conduct-Alcohol Related and released.

## [16-0623] Urinating in Public

Tomah officers were dispatched to Tomah Lumber to meet with a male who was possibly having some type of medical issue. Officers arrived and met with an extremely intoxicated subject who claimed his heart hurt. An ambulance was summoned to address the medical complaint. An officer observed a liquid on the steps to Tomah Lumber and determined the male subject had urinated all over them. The male subject was issued a citation and released. The male subject was transported to Tomah Memorial Hospital for his medical complaint.

# [16-0633] Operating a Motor Vehicle Without Owner's Consent, Criminal Trespass to Dwelling, Disorderly Conduct, Bail jumping-Felony

Tomah officers responded to the 1100 block of Mark Avenue for a reported disturbance. Officers arrived and learned an ex-boyfriend to the victim had broken into her home, created a disturbance, ripped her shirt and stole her vehicle. The male suspect fled prior to officer arrival. Officers had phone contact with the suspect and he indicated he wasn't going to turn himself in. A warrant has been requested to be issued for the suspect through the Monroe County District Attorney's Office.

# [16-0634] Battery, Disorderly Conduct, 4th Degree Sexual Assault, Theft, Probation Hold, TOPD Warrant

Tomah officers responded to the Day Break Motel for a reported disturbance. Officers arrived and learned that a male subject had punched and slapped a female victim. Additionally, the female victim indicated the male grabbed her in a private area. Officers were familiar with male suspect and located him at an address on Mill Avenue in the City of Tomah. The suspect was highly intoxicated and only admitted to being at the same location as the victim. The male was arrested for Disorderly Conduct, 4<sup>th</sup> Degree Sexual Assault, Battery, a Tomah Police Department Warrant and a Probation Hold. Further investigation revealed the suspect had stolen \$20 from the victim. A charge of Theft was added and the suspect was booked into the Monroe County Jail.

### [16-0638] Theft, Probation/Parole Hold, Bail Jumping

Tomah officers responded to Tomah Memorial Hospital for a theft complaint. The officers arrived and were informed that a male subject had taken a thermometer off the wall, concealed it upon his person and attempted to leave. The suspect was confronted by Emergency Department staff and surrendered the thermometer before departing. The act of Theft was captured on hospital surveillance cameras. The suspect was located and determined to be on parole for Burglary and Possession of Methamphetamine. The suspect attempted to lie but was confronted with the video evidence and then admitted to his involvement. The suspect was placed on a Parole Hold and booked into the Monroe County Jail on charges related to this crime.

# [16-0639] Criminal Trespass to Dwelling, Disorderly Conduct, Intimidation of a Victim/Witness, Bail Jumping

Tomah officers responded to an address on the 400 block of West Jackson Street. for a damage to property complaint. Officers arrived and learned a male subject had entered the residence, without consent, and proceeded to spread lotion and shampoo all over. The male suspect was not on scene but was on the phone with the victim. The suspect admitted that he did enter the property and did spread the substances around. The suspect was believed to be in the La Crosse, Wisconsin area and was subsequently located by La Crosse Police Department and arrested. Tomah officers learned that the suspect had threatened to kill the victim if he went to jail. The suspect was booked at the Monroe County Jail.
