POLICE CHIEF WES REVELS

CHIEF'S ACTIVITIES:

I attended a meeting with representatives of the area law enforcement agencies and health care facilities. The purpose of this meeting was to discuss issues related to Wis. Stats. Chapter's 51 and 55 (Emergency Detentions). In the past it was the responsibility of law enforcement to make the decisions as to who would be taken into custody in respect to emergency detentions. The authority now lies with Monroe County Human Services. This legislative change has caused some concerns, many of which were discussed at this meeting.

I attended a meeting of the Monroe County Safety Coalition. We continue to discuss issues related to highway safety, underage alcohol consumption and tobacco use. As I've indicated in the past, the Department is increasing our involvement in the program titled, "Parents Who Host Lose the Most: Don't Be a Party to Underage Drinking" which is an element of the Alcohol and Drug Abuse School Community Alliance Coalition. As some of you may be aware of, Lt. Nicholson wrote a Highway Safety Grant for a sub-component, the Youth Alcohol Enforcement Project. The sub-component project is called the Comprehensive Alcohol Risk Reduction (CARD) Project. We recently received notification that our Department was granted \$4,000.00. We are required to utilize the funds for Compliance Investigations, Cops in Shops and other underage alcohol enforcement activities. At this meeting I also gave a presentation on our Community Pride Program.

I attended a meeting with representatives from Salvation Army. We meet as needed to discuss the emergency funds that are available. Salvation Army makes funds available to area law enforcement agencies that can be used to assistance transients. All others who are in need of emergency services are referred to Families First. The funding system is administered through a voucher system; no currency is keep on hand.

As a reminder to the Common Council, the Our Town Tomah Committee has scheduled a Spring Cleanup to take place on April 23 from 8:30 a.m. to 1:00 p.m. We will be receiving assistance from the Monroe County Community Services Program, some of Tomah's business owners and the environmental group, Roots and Shoots from the Tomah Senior High School.

I attended the Wisconsin Chief's of Police Mid-Winter Training Conference. This is an annual conference usually held in February of each year.

This year we will finalize our plans to become a permanent drop off site for unwanted medications and prescription drugs. This will coincide with plans that we have to work with Tomah Memorial Hospital in holding a second drop off event that will take place on Earth Day (April 22, 2010).

INVESTIGATIONS

[10-0238] Possession of Marijuana, Possession of Drug Paraphernalia

Tomah Officers were dispatched to the 1100 block of Hollister Ave. for a reported intruder. Additional information was that the home owner was holding the subject inside the residence at gun point. Officers arrived and successfully took the subject into custody. The subject was in possession of marijuana and drug paraphernalia. The subject was cited and released.

[10-0306] Possession of Marijuana, Possession of Drug Paraphernalia

Tomah Police were dispatched to Band Box Cleaners for a report of a suspicious person. Additional information was that this person had asked a person at the Laundromat where he could buy some marijuana. Officers located the subject and determined the subject was in Tomah for a short period of time and was waiting for the Amtrak train to arrive in Tomah. The subject was traveling to Chicago, IL for a court appearance. The subject admitted to possessing marijuana and drug paraphernalia. The subject was taken into custody and transported to the Monroe County jail.

[10-0338] Burglary, Possession of a controlled substance, Theft, Possession of Amphetamine

Tomah Police investigated a theft complaint that occurred at one of the schools in the City of Tomah. Evidence was provided to the Police that showed video of a subject entering a locked room to steal student's prescription medications. This subject was subsequently taken into custody, brought to the Tomah Police Department and interviewed. The subject admitted to entering the school with the intent of stealing prescription medications. The subject was taken to the Monroe County Jail.

[10-0340] 2nd-Degree Recklessly Endangering Safety, Disorderly Conduct, Battery

Tomah Police were dispatched to Tomah Memorial Hospital to meet with a subject who had been involved in a physical altercation on the 400 block of N. Glendale Ave. This female subject indicated she was involved in an altercation with her boyfriend's other girlfriend. During the altercation this subject indicated she punched and pulled the hair of the other girlfriend. The other girlfriend grabbed a large glass liquor bottle that was full and struck her over the head. The bottle shattered and this female received a deep laceration to her left wrist. This female had x-rays taken and her arm was also broke. The female subject that used the bottle as a weapon was taken into custody and transported to the Monroe County Jail. The injured subject will be referred to the DA's Office for Battery and Disorderly Conduct.

[10-0376] Disorderly Conduct, Battery, Obstructing an Officer, Battery to Law Enforcement Officer

Tomah Police were conducting foot patrol in the downtown bar district. Officers observed a subject inside Dimensions who had a warrant for his/her arrest. Officers had contact with this subject on the crowded dance floor and escorted this person outside. Once Officers were outside several friends and family members exited the bar and began to interfere with Officers. Several of these subjects became physically resistive towards Officers and were taken into custody. During the arrest of these subjects several more people attempted to interfere with the Police; this caused Officers to request assistance from other Police agencies. One of the subjects intentionally kicked a Tomah Police Officer in the groin. Officers were able to restore order and several subjects were taken to the Monroe County Jail.
