### **OPERATIONS LIEUTENANT ACTIVITIES**

The following is a list of tasks/assignments/responsibilities carried out in the month of January, 2013 by Lieutenant Mark Nicholson:

Completed requests made by the City Attorney's Office and the District Attorney's office for copies of evidence related to audio, video and pictures. Managed and processed the open records requests for audio and video related evidence

Conducted shift supervisor activities on many of my regularly scheduled shifts.

Assisted in the weekly monitoring of the Prescription Drug Drop Off Box located in the lobby of the Tomah Police Department.

Monitored and processed incoming temporary evidence, assuring that it was properly packaged and labeled. Once this was completed the evidence was processed into the evidence room. 168 pieces of evidence were processed into the Evidence Room throughout the month. Monitored and processed dispositions of cases in which evidence is to be disposed of.

Managed all schedule related issues for all sworn department members. This task included schedule variations related to comp time, vacation time, court time, training time, sick leave, and special assignments.

Assisted in the facilitation of the department's social media networks to include Facebook and Twitter.

Attended Administrative and Command Staff meetings held at the Tomah Police Department.

Attended a meeting held at the Monroe County Sheriff's Department for an upcoming High Visibility Enforcement Grant which the Tomah Police Department, Sparta Police Department and the Monroe County Sheriff's departments will be participating in.

Attended a meeting with the Monroe County Agricultural Society to discuss the 2013 Grand National Tractor Pull and Shell Rotella Super Rigs Show which will be held in Tomah June 20-23, 2013.

Attended a 911 Advisory Board meeting.

Attended the departments bi-monthly training session held at the Police Department. Topics addressed were Multi-Assault Counter-Terrorism Action Capabilities (MacTac), emergency medical care and Chapter 51/55 updates.

### SUPPORT SERVICES LIEUTENANT ACTIVITIES

The following is a list of tasks/assignments/responsibilities carried out in the month of January, 2013 by Lieutenant Ron Waddell:

As part of Fleet Maintenance oversight, two new vehicles were purchased. One 2013 Ford Interceptor Utility, and the other a 2012 Chevy Impala. The Interceptor will be a patrol vehicle and the Impala will be used by the investigations bureau. With these additions of new cars two existing vehicles were removed from the fleet.

During the month I continued as a shift supervisor on many of my shifts, performing Time Agency Coordinator duties, and attending staff meetings (Command and Administrative level). There were building maintenance issues also handled during this month.

This month saw a large volume of medications being dropped in the lobby repository, which were then removed and secured for safekeeping and future disposal.

### **COMBINED TACTICAL UNIT**

### Call Out:

On the morning of 01/26/13 La Crosse Police requested assistance in attempting to locate a stolen vehicle. La Crosse Police reported that the suspect lived on Franklin Street in Tomah and he was a suspect because he was contacted by police in the area where the vehicle was stolen. Further information was developed that the suspect was acting strangely when police had contact with him. At approximately 6:40a.m. Officer Keller located the stolen vehicle in the back yard of the suspect's residence on Franklin Street. Attempts to contact the suspect by knocking on the door and cellular telephone were unsuccessful. Officers at the location located one set of footprints in the fresh snow that led from the stolen vehicle to the residence. On-duty personnel requested assistance from tactical officers and four tactical officers from the Tomah Police Department responded. With consent of the suspect's wife the tactical officers breached the door from the garage into the residence. Tactical officers later entered the residence to search for the suspect. Upon entering the kitchen area the suspect called out from down the hallway and stated that the police were on the way and that he was armed. After a brief period of communication with the suspect he came to the kitchen area unarmed and was taken into custody without incident.

### **Training:**

Training was conducted in Tomah and began at the Tomah Police Department before moving to an abandoned house on Grain Avenue. Classroom training at the Tomah Police Department consisted of our team meeting and the classroom portion of the chemical agents training. Once we arrived at the structure a neighbor advised us that they were aware that the house was full of black mold. Inside inspection did reveal a large amount of potential black mold inside the structure. Black mold presents an inhalation hazard to humans and therefore we decided to not conduct any significant interior training at the structure. We did have the opportunity for each team member to fire a 37mm "Ferret" round into the house from approximately 25 yards away. All team members (except Weaver and Nelson who attempted much farther shots) were successful in hitting their designated window. Team members also practiced several approaches and breaches on the rear door that was repaired and reinforced with screws as needed. A crisis hostage rescue entry was conducted with a two team, one conducting a ladder window break and rake and the second breaching the door and deploying a Flash bang was conducted. Finally we had the opportunity to practice approximately 15-20 break and rakes on various windows by removing the exterior windows, breaking the interior windows and then replacing the exterior windows and breaking them. Destructive breaching and window break and rakes are rarely practiced live due to the damage caused and this was a great opportunity to refine our timing and skills.

### **INVESTIGATIONS**

[13-0002] Operating a Motor Vehicle While Intoxicated  $-2^{nd}$  Offense, Resisting an Officer, Open Intoxicant in Motor Vehicle

Tomah Officers received a complaint from the wife of a male subject who she claimed had been consuming alcohol and illegal drugs. The subject and his vehicle were located a while later and a traffic stop was conducted. An officer spoke with the operator and then returned to the squad car to conduct a records check. The subject then exited the vehicle and began sprinting away from the traffic stop. Another Tomah Officer was on scene and was able to quickly close the distance and the subject was decentralized. The subject refused to comply with numerous commands to cooperate and stop resisting arrest. The subject refused to remove his hands from underneath his body and this posed an immediate and obvious officer safety concern as the subject wasn't searched and may be armed. A collapsible baton and OC were used to overcome the subject's active resistance. Officers were eventually able to secure the subject with handcuffs. The subject was transported to Tomah Memorial Hospital for a legal blood draw as well as to be treated for some minor injuries sustained while resisting arrest. The subject was medically cleared and transported to the Monroe County Jail.

# [13-0019] Possession of Heroin with Intent to Deliver, Administer Dangerous Drug, Bail Jumping-Felony, Heroin Delivery

Tomah officers received information that a male subject had overdosed at a residence in Tomah and a drug had to be administered to him to keep him alive. This drug was not administered by medical personnel. Officers learned this took place at an address on Dogwood Lane in the City of Tomah. Officers conducted a thorough investigation that led to the service of a search warrant at this address. Officers were able to take two subjects into custody and seized a sizeable amount of heroin. The suspects were transported to the Monroe County Jail.

# [13-0040] Operating a Motor Vehicle While Intoxicated, Operating After Suspension, Warrant Arrest

A Tomah officer stopped a vehicle for a traffic violation. The Officer determined the vehicle operator had been consuming alcohol. Standardized Field Sobriety Tests were conducted and probable cause was established to arrest the operator. The operator did not have a valid driver's license. The operator submitted to a Preliminary Breath Test and the result was .205 BAC. The subject was transported to Tomah Memorial Hospital for a legal blood draw and then was transported to the Monroe County Jail.

# [13-0093] Operating a Motor Vehicle While Intoxicated, Operating a Motor Vehicle with a Prohibited Alcohol Concentration

An off-duty Veterans Affairs Officer reported that an intoxicated subject was attempting to drive a vehicle from the area behind the Tee Pee Supper Club. The VA Officer urged the subject to not drive and the subject shut the vehicle off but remained seated inside. A Tomah officer arrived a short time later and met with the VA Officer. As the Tomah officer arrived on scene the suspected intoxicated driver drove away. The vehicle was stopped and Standardized Field Sobriety Tests were attempted but not completed due to the level of intoxication. Probable Cause was established to arrest the subject. The subject was brought to the Tomah Police Department for processing. A chemical test of the subject's breath was conducted and the subject's Blood Alcohol Concentration was .23 BAC; almost four times the legal limit. The subject was unable to locate a responsible party and was subsequently transported to the Monroe County Jail.

[13-0112] **Disorderly Conduct, Possession of Marijuana, Possession of Drug Paraphernalia** Tomah Officers responded to an address on the 1100 block of Superior Avenue. for a welfare check. Officers had contact with a female subject who had cut her wrists to the extent that the injury would require medical attention. The Monroe County Human Services placed the subject on an Emergency Detention and she was transported to Tomah Memorial Hospital for medical clearance. At the hospital the subject's demeanor changed from relatively cooperative to highly uncooperative. The subject began screaming at the Police, cursing and threatening to hit/punch the Officers. The subject was ultimately transported to a medical facility in La Crosse, WI. When the subject arrived at the La Crosse hospital she was escorted into the facility. A short time after being escorted into the facility she turned and spit a mouthful of bloody saliva all over the face and chest of a Tomah Police officer. The subject was restrained until she could be released to hospital security personnel.

### [13-0113] Use/Abuse Hazardous Material, Retail Theft

Tomah Officers responded to Walmart for a report of a subject shoplifting. Officers arrived and learned the suspect had stolen a can of compressed air and was 'huffing' it in the vestibule area of the store. The suspect was arrested and transported to the Monroe County Jail.

[13-0115] Strangulation and Suffocation, Criminal Damage to Property, Disorderly Conduct Tomah Officers responded to an address on the 300 block of Kilbourn Avenue for a disturbance. Officers met with a female victim who stated her boyfriend had choked her during an altercation. The investigation revealed the male suspect became upset with the victim. The victim told the male suspect that she was going to call the Police. As the female victim was trying to call the Police the suspect pushed her down and choked her. The male suspect was located, arrested and transported to the Monroe County Jail.

### [13-0123] Operating a Motor Vehicle Without Owner's Consent

Tomah Officers received information that a stolen vehicle might be at an address on Franklin Street in the City of Tomah. A Tomah Officer responded to the area and located the stolen vehicle in the backyard. Tomah Police Department members that are assigned to the Monroe County Combined Tactical Unit were used to locate and arrest the suspect. The suspect was located inside his residence where the vehicle was located. The suspect was taken into custody and evidence was seized that may link the suspect to crimes in La Crosse County. The suspect was transported to the Monroe County Jail.

### **TRAINING**

In January, the sworn members of the department participated in training that included updates related about Emergency Detentions (Wis. Stats. Chapter's 51 and 55). These updates were provided by Corporate Counsel Andy Kaftan and Monroe County Human Services Agent Sue Rettler. Active shooter training was provided by Sgt. Weaver and Sgt. Pedersen.
