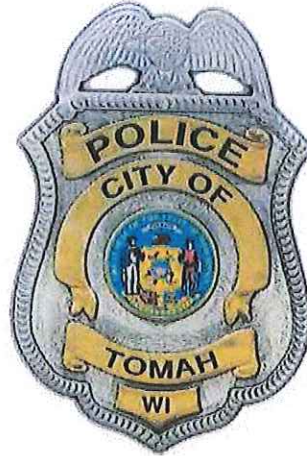

**January 2014 Report**

## OPERATIONS LIEUTENANT/CHIEF ACTIVITIES

The following is a list of tasks/assignments/responsibilities carried out in the month of January 2014.

During the month of January I was appointed the Chief of Police.

I attended the monthly Committee of Whole meeting.

I attended a Business and Industry Luncheon sponsored by Tomah Memorial Hospital. There was a presentation regarding implementation of an incentive based health and wellness program for private and public sector employers.

I attended the Coulee Region Executive Law Enforcement quarterly meeting. This meeting is attended by area Law Enforcement Executives...Chiefs, Sheriffs, etc... to discuss events and incidents occurring in and around the Coulee area.

I attended and participated in a table top exercise involving an active shooter. Agencies in attendance included the Tomah Area School District, Tomah Fire Department, Tomah Emergency Management and Monroe County Emergency Management. The exercise allowed an open forum to discuss with the other agencies what our plans and responsibilities are during an event like this and conversely look at what other agencies will be doing.

I conducted shift supervisor activities on many of my regularly scheduled shifts.

I assisted in the weekly monitoring of the Prescription Drug Drop Off Box located in the lobby of the Tomah Police Department.

I monitored and processed incoming temporary evidence, assuring that it was properly packaged and labeled. Once this was completed the evidence was processed into the evidence room. 126 pieces of evidence were processed into the Evidence Room throughout the month. I monitored and processed dispositions of cases in which evidence is to be disposed of.

I assisted in the facilitation of the departments Social Media Networks to include Facebook and Twitter.

I attended bi-weekly meetings with other Department Supervisors.

I attended the Monroe County 911 Advisory Group meeting held in Tomah. This meeting was attended by various agencies to include Dispatch, Law Enforcement, Fire, EMS and Emergency Management.

I instructed a class to the Monroe County Sheriffs Reserve Recruit Class. Topics discussed during my presentation included; officer responsibility while off duty, officers actions in public, procedures when serving in the City of Tomah, working with a K9 Unit. I also provided them with a tour of the Tomah Police Department.

I attended training for new Chiefs and Sheriffs. This training was sponsored by the Wisconsin Department of Justice and held in Madison. The training is held annually. This event was attended by 40 new Chiefs and 4 new Sheriffs. The cost of the training, to include registration, lodging, meals was paid for by the Department of Justice.

Reviewed open record requests and completed required redactions and other duties related to the same.

I met with reps for the Tomah Cancer Run that is being planned for sometime in May

## **INVESTIGATIONS**

### **14-0004] Substantial Battery, Bail Jumping**

Tomah Officers responded to Dimension's Bar for a reported disturbance. Officers arrived and learned two male subjects were involved in an altercation and one of the male subjects had been punched repeatedly and rendered unconscious. The suspect was located and taken into custody. Officers learned the victim had received fractures to his face.

**[14-0046] Felon in Possession of Firearm, Bail Jumping**

Tomah Officers were dispatched to the area of the 400 block of North Glendale Avenue after receiving a call that a male subject stated he had been shot. As Officers were arriving they were informed that a male subject had been dropped off at the hospital and was suffering from a gunshot wound. Officers conducted a lengthy investigation and determined the male subject was handling a firearm and shot himself, believed to be unintentional, in the stomach. The male subject was flown to Gunderson Health System in La Crosse, Wisconsin. Charges will be referred to the Monroe County District Attorney's Office.

**[14-0102] Operating a Motor Vehicle While Intoxicated (OMVWI), Prohibited Alcohol Concentration, Speed too Fast for Conditions**

A Tomah Officer was traveling on North Superior Avenue and observed a vehicle in the median. The Officer contacted the operator and believed he may be impaired. The operator agreed to go to the Tomah Police Department where field sobriety tests could be conducted in a warmer location. The operator was arrested for OMVWI after the Officer established probable cause. The operator was processed at the Tomah Police Department. The operator's Blood Alcohol Concentration was determined to be .29; over three times the legal limit. The operator was transported to the Monroe County Jail.

**[14-0116] Possession of Synthetic Cannabinoid, Possession of Drug paraphernalia, Resisting Arrest, Disorderly Conduct, Mistreatment of Animal**

Tomah Officers responded to an address on 1400 block of Kilbourn Avenue for a juvenile who was out of control. Officers arrived and met with a 13-year-old male, his mother and two Intensive Supervision Workers. The juvenile was angry and had been smoking "K2", a synthetic Cannabinoid. The juvenile was being taken into custody at the request of the workers. At one point the juvenile kicked a cat and the Officers learned this was the second time the juvenile had done this. The juvenile was taken into custody but not before fighting and resisting arrest. The juvenile was transported to Sparta where he was turned over to a Monroe County Transport team.
