March 2015 Report

### **CHIEF'S ACTIVITIES**

The following is a list of tasks/assignments/responsibilities carried out in the month of March 2015:

I attended a Monroe County Child Abuse Task Force meeting.

On March 30, 2015 a Congressional Field Hearing was held in the City of Tomah. An event such as this has not only never been held in our area, one has never been held during the current congressional members tenure. Several times throughout the month of March members of our Administrative Staff met and spoke with staff members from Senator Johnson and Senator Baldwin's offices to plan for this event. As a result of the team work and collaboration with their staff the hearing was held with no issues. Our department received several compliments and comments of appreciation from the congressional members.

I attended the monthly Committee of the Whole meeting.

I attended the Monroe County Safety Coalition monthly meeting.

I attended the City of Tomah Emergency Planning meeting.

I attended an Our Town Tomah meeting.

I attended a Coulee Region Law Enforcement Executive Group (CRLEEG) meeting held in Prairie du Chien. This is a quarterly meeting which is attended by Chiefs, Sheriffs and Command Staff members of the State Patrol.

I attended an Ad Hoc Alcohol Review Committee meeting.

I attended bi-weekly meetings with other City of Tomah Department Supervisors.

On March 11, 2015 a death investigation was initiated in the City of Tomah. As a result of the investigation it was determined that the cause of death was a homicide. Within 48 hours of the initial call two suspects were identified as having traveled from Idaho, stopping in Tomah, and then immediately leaving the City of Tomah and the State of Wisconsin after committing the homicide. On March 22, 2015 the suspects we identified were arrested in the State of Tennessee. As the Chief of Police I provided oversight to the investigation and authorized expenditures which, although not budgeted for. where necessary and required. These expenditures included overtime, meals, lodging and travel expenses related to officers completing investigations in states between Idaho and Wisconsin and then again from Wisconsin to Tennessee. Additional expenses was incurred and authorized to bring the suspect's vehicle back to Wisconsin to be processed by the Wisconsin Department of Justice Crime Lab. At this time the

suspects have been charged with homicide and are awaiting extradition back to the State of Wisconsin. Follow up investigation is ongoing.

I attended a Monroe County Coordinated Services Team meeting.

I attended Board of Director meetings for the West Central Boys and Girls Club and the Tomah Area Boys and Girls Club.

I attended the Monroe County Justice Coordinating Committee meeting.

### **OPERATIONS LIEUTENANTACTIVITIES**

The following is a list of tasks/assignments/responsibilities carried out in the month of March 2015 by Lieutenant Ron Waddell:

I along with Chief Nicholson and Lt. Holum attended a listening session regarding the process to becoming a Core Accredited Agency.

All scheduling responsibilities (time off, overtime, special events, etc.)

Facilitated responsibilities as a Time Agency Coordinator (TAC), scheduling online recertification and conducting expiration audits. Task is shared with Lt. Scott Holum

I conducted shift supervisor activities on several of my regularly scheduled shifts and was available for incident command/high risk calls

I assist with incoming temporary evidence as needed. The evidence responsibilities also required return of evidence and limited destruction of evidence as time permitted. Evidence was provided to officers for follow-up and/or turn over to other police agencies.

In order to provide a complete review of all Tomah Police Department Policy and Procedures a review committee has been formed (Lt. Waddell, Lt. Holum, Sgt. Weaver and Officer Hintz). Each member has been assigned a portion of the policies and procedures to review for accuracy and compliance for current practices and application. This process, at least the assigned policies I had, were completed and stand ready for a total board review, which will occur April 1, 2015.

Chief Nicholson received a request to provide staff for security at the Congressional Field Hearing held at the Cranberry Country Lodge March 30, 2015. Chief Nicholson assigned me to coordinate and liaison with Congressional Staffers in an effort to insure a safe event. Several meetings were held in the weeks leading to the event, along with a vast flow of e-mails. I created a security plan utilizing six (6) uniformed officers and two (2) plain clothes officers. Three (3) staff were from the Monroe Sheriff Department and one (1) from the

Wisconsin State Patrol. The State Patrol included the bomb sniffing K-9. With the number of officers mentioned the overtime hours were significantly minimized by utilizing on-duty, or regularly scheduled officers. No reimbursement will be required for the utilization of Monroe County or Wisconsin State Patrol. Tomah Police Department did utilize one employee on overtime for 2-hours. The event, from a security point-of-view, was successful.

Using the Wisconsin Surplus Online Auction site, I entered one of the last two Crown Vic squads for sale. This squad sold for \$3,749, which was a little above our average sales on this website for a similar vehicle.

### SUPPORT SERVICES LIEUTENANT ACTIVITIES

The following is a list of tasks/assignments/responsibilities carried out by Lieutenant Scott Holum in the month of March 2015:

I conducted Shift Supervisor responsibilities on some of my shifts.

I monitored the Prescription Drug Box in the front lobby of the police department.

Sergeant Preuss and I processed all incoming evidence.

I oversaw the Field Training program that is supervised by Sergeant Pedersen. Officer Franks and Officer Gimson are now each on solo patrol.

I provided oversight to Sergeant Huneck and Sergeant Jones concerning the Fleet Maintenance program with scheduled and unscheduled repairs.

I assisted Lt. Waddell in scheduling related matters.

I performed the duties as the department's Time Agency Coordinator (TAC) and scheduled recertification training for department staff.

I reviewed cases that were purged through NCIC to determine if stolen items needed to be put back into NCIC.

I have been working closely with Kody Steinhoff. Kody joined our department in late 2014 and comes in once a week to wash squad cars. Kody's time with the Tomah Police Department has now ended.

I, along with Lieutenant Waddell, acted as the Critical Incident Commander for a Homicide Investigation at the Econo Lodge.

TRAINING REVIEW:

Two training sessions were conducted in March  $-1^{st}$ : Nine members of the Combined Tactical Unit attended the Wisconsin Association of SWAT Personnel conference in Milwaukee. This conference consisted of the following training sessions: Extremist Leadership & Critical Decision Making (Los Angeles PD SWAT Officer), N. 5<sup>th</sup> Road Homicide/Officer Involved Shooting Debrief (Marinette County, WI Sheriff's Department), Hidden Places Hostage Incident Debrief (Eau Claire, WI Police Department SWAT and Negotiators), Adaptive Leadership (Retired Los Angeles County Sheriff's Department Commander). Rescue Task Force – Coordination of Police & EMS for Active Shooter Incidents (Arvada Colorado Police), Lessons Learned from Hostage Rescue Operations (Los Angeles County Sheriff's Department SWAT Deputy), St. Petersburg Murdered Officers/Barricade Incident Debrief (St. Petersburg, Florida SWAT Officer). 2<sup>nd</sup> – Team members from Monroe County Sheriff, Sparta Police and Wisconsin State Patrol were trained in 12 gauge and 37mm less-lethal projectiles. This training was important as it gives us the ability to utilize a 37mm less-lethal launcher owned by the Monroe County Sheriff's Department on CTU call outs. The 37mm less-lethal projectile launcher will be stored in the MRAP armored vehicle and provide us with an always present less-lethal option inside the inner perimeter. Tomah Police Department personnel conducted the lesslethal projectiles training and other Tomah Police Department CTU personnel did not need to attend this training since they were current on this topic.

### **INVESTIGATIONS**

### [15-0366] Disorderly Conduct - Alcohol Related

An officer was in the downtown bar district observing the crowds at bar time. The officer observed a fight in front of Dimensions Bar. The officer responded and was able to stabilize the scene. The Officer had contact with a male subject who had a bloody lip. The male subject was rude, disrespectful and uncooperative with the Police and provided no information to aid officers in establishing what happened. The male subject was released and officers remained in the area. Almost immediately, the Officers observed a female subject fall hard onto the sidewalk and the male subject walking away. The male subject was stopped, placed in handcuffs and escorted away. The female subject was determined to be the male's girlfriend and both of them refused to provide any details to the Police and denied all allegations. The male subject was cited and released.

### [15-0377] Battery to Emergency Medical Care Worker

Officers were summoned to Tomah Memorial Hospital Emergency Room for a report of a patient who had struck a nurse. Officers arrived and met with a nurse who indicated she had been punched, with a closed fist, by a patient who was still at the hospital. Officers met with a subject who they are familiar with from prior Police contacts. This subject was intoxicated and creating another disturbance as Officers were trying to gather information. The subject was discharged and transported to the Monroe County Jail.

# [15-0403] Operating a Motor Vehicle with a Prohibited Alcohol Concentration - Felony

A Tomah officer stopped a vehicle for an equipment violation. The officer had personal contact with the operator and the operator admitted to consuming 'three' drinks at his residence. The officer learned that the operator had three prior OWI convictions and had a restriction indicating not to have a blood alcohol concentration greater than .02. The officer administered one field sobriety test and then a preliminary breath test. The operator's breath indicated an alcohol concentration greater than .02 (Actual reading was

.078). The operator was taken into custody, transported to the Police Department for processing and ultimately released to a responsible party.

### [15-0421] Public Nuisance – Urinating in Public

An officer was traveling through the downtown bar area and observed a male subject between two vehicles. This subject displayed common mannerisms with a male who would be urinating. Further investigation revealed obvious evidence that a person had urinated in the exact spot the male was observed in. Contact was made with the male subject and he displayed signs of intoxication. The male subject was cited and released.

[15-0430] Possession of Methamphetamine, Possession of Marijuana, Child Neglect Tomah officers responded to Econo Lodge for a welfare check on several small children. Additionally, officers were informed the adults who were with the children had been overheard talking about 'Meth.' Officers arrived and could smell an odor of burnt chemicals that got stronger at the suspected room. Officers had contact with two females and were invited into the room. Three small children were observed in the room sleeping. The chemical odor was very strong inside the room. Officers obtained consent to search the females and when doing so one of them tried hiding a vial that contained a white crystal substance consistent with methamphetamine. This female subject resisted arrest and when secured with handcuffs had a vial of suspected contraband in her hand along with a knife. Additional items of contraband were seized and this female was taken to the Monroe County Jail. The other female displayed no signs of impairment or drug use and was permitted to take the children to her residence. This case will be forwarded to the Monroe County Department of Human Services.
