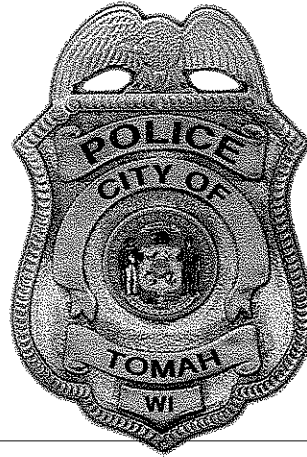

## **CHIEF'S ACTIVITIES**

I attended a meeting of the Monroe County Safety Coalition.

I attended a luncheon sponsored by the Wisconsin Bureau of Transportation. At this luncheon the Department won a Laser Radar valued at approximately \$2,000.00.

## **OPERATIONS LIEUTENANT ACTIVITIES**

The following is a list of tasks/assignments/responsibilities carried out in the month of October, 2011 by Lieutenant Mark Nicholson:

Completed requests made by the City Attorney's office and the District Attorney's office for copies of evidence related to audio, video and pictures.

Attended an Administrative Staff meeting.

Conducted shift commander activities on many of my regularly scheduled shifts.

Monitored and processed incoming temporary evidence, assuring that it was properly packaged and labeled. Once this was completed the evidence was processed into the evidence room.

Managed and processed open records requests for audio and video related evidence.

Managed all schedule related issues for all sworn department members. This task included schedule variations related to comp time, vacation time, court time, training time, sick leave and special assignments.

Supervised the National Medication Take Back Day held on October 29, 2011. This event is administered by the United States Drug Enforcement Administration. In May 2011, the Tomah Police Department participated in a similar event. During this event 376,000 pounds of unwanted/unneeded medications were turned into Law Enforcement nationwide.

Attended a one day training seminar on the Investigation of the Use of Force and a one day training seminar related to updates for the Badger TraCS automated citation program.

Attended training sponsored by the Wisconsin Department of Justice for the new laws related to carrying a concealed weapon. After receiving this information I presented information to the Lions Club and the Tomah Area of Chamber of Commerce to discuss these laws and how it may affect their members.

## COMBINED TACTICAL UNIT

### Monroe County Combined Tactical Unit Training Report - 10/05/11

#### **Training:**

Training was conducted at the Kendall Elementary School. Sgt. Ames was able to secure the Kendall Elementary School, which is presently not being used, for training purposes. After conducting our team meeting we toured the building to gain experience in the building design and for general experience regarding the layout and construction of school buildings. After the tour we conducted basic building clearing exercises using various equipment and building searching techniques.

### Monroe County Combined Tactical Unit Training Report - 10/19/11

#### **Training:**

Training was conducted at the Recreation Park and the Tomah Airport with K-9 Units from Tomah Police, Sparta Police, Jackson County Sheriff and Juneau County Sheriff. The goal of the training was to work with the Bloodhounds from the Jackson County Sheriff Department and Juneau County Sheriff Department in a tactical manhunt situation. The K-9s from Tomah Police and Sparta Police participated in the searches at the end of the search once the Bloodhound had trailed the suspect to a building or an area. During the searches tactical team members were divided up into three different assignments: cover officers for the K-9 teams and a tactical over watch team on the right and left side of the K-9 teams. We were able to work five different searches and included a track to a building where the each dog was sent into the building to find and apprehend the suspect, a search where the suspect ran on foot upon approach and the bite dogs were sent to apprehend the suspect and a search for the Tomah Police K-9 where the suspect was located in the woods approximately 40 yards away and the K-9 was then sent to find and apprehend the suspect. Tactical team members were able to practice rural movements and communication during the searches.

## SCHOOL RESOURCE OFFICER

#### **Monday, October 3rd**

Responded to Goodwill to pick up a disorderly student. Student was cited for disorderly conduct.

Assigned cafeteria supervision.

Contact with a male subject reference trespassing. Subject left the property.

#### **Tuesday, October 4th**

Contact with a student in regards to an accident in the parking lot. Student was provided with a self report form.

Contact with a student who reported their vehicle was keyed while parked in the parking lot on 10-3-11.

Contact with a student who indicated they were invited to a party at a friend's house this coming weekend. The friend indicated the student would have marijuana to smoke while they were there.

Teacher reported a smoke smell outside the window of her classroom. It was later discovered another class was having a fire safety demo and the odor may have been coming from there.

Contact with a student in regards to a welfare check. She received a message indicating her boyfriend made comments about killing himself. The Wilton Chief checked on the boyfriend who was fine.

Contact with a student in regards to GDL violation.

Citation served to a student for habitual truancy.

Contact with a two students in regards to harassment.

Contact with male subject on school property.

**Friday, October 7<sup>th</sup>**

Senior Health and Safety Expo and Range training.

Contact with a student in reference to driving issue outside the high school parking lot.

**Monday, October 10th**

Met with parent and student in regards to a fight that had occurred after school on Friday.

Received six reports for habitual truancy from Tomah High School.

**Tuesday, October 11th**

Met with a student and the student's parent in regards to the student being harassed by her ex-boyfriend. The school administration will follow up with a trespassing letter and family was going to seek a restraining order.

Sergeant Huneck and Investigator Walensky assisted with a student in regards to harassment. Student was disorderly with administration and law enforcement. Student was removed from school by officers, cited for disorderly conduct and released to parent.

Intervened in potential fight at lunch in the parking lot.

**Wednesday, October 12th**

Met with a student in regards to suicidal thoughts. Parents agreed to work on intervention for student.

Follow up with student in regards to obtaining restraining order.

Contact with special education teacher in regards to family/living concerns of a student.

Spoke with a staff member at the Tomah Middle School in regards to damage to property complaint. Principal indicated he would take care of it and we could meet with the student at a later time.

Department training in the afternoon.

Sick leave for half day.

Received a habitual truancy referral from Tomah High School.

**Friday, October 14th**

Circuit Court in the morning.

Spoke with a parent in regards to attendance issues and possible truancy.

Follow up phone call with a parent in regards to the fight that occurred last week.

Spoke with a parent in regards to harassment and bullying with a neighbor child that is also occurring at school. Parent has also set up a time to meet with the school.

Spoke with the student from Tomah Middle School and the damage to property complaint from Wednesday.

Served several habitual truancy citations.

Talked with a student and parent in regards to leaving school during the pep rally.

Spoke with a student who was walking near the school during the pep rally. Student indicated they was not feeling well and were walking home. Courtesy call made to the parents.

Spoke with a student who was walking near the school instead of attending pep rally. Student returned to school.

Report of an accident in the parking lot at lunch. Report to be completed.

### **Saturday, October 15th**

Attended the Homecoming Dance. Two reports of thefts from motor vehicles which occurred from the parking lot during the dance.

Underage alcohol violation.

### **Monday, October 16th**

Kindergarten tours in the morning.

Follow up with subjects in regards to the thefts from vehicles during the dance. Received one additional report of a theft from a motor vehicle that occurred during the dance. Talked with two suspects in regards to the thefts. Also conducted a search of a vehicle in regards to the thefts. Received a tip from a student who indicated they saw 4 students going through vehicles during the dance.

Spoke with a student in regards to a Chapter 51. Student did not meet the criteria but parent did come and pick the student up based on the concerns.

### **Wednesday, October 19th**

G.R.E.A.T. Instruction

Met with Tomah Middle School student in regards to disorderly behavior on the 18th. Student to be cited for Disorderly Conduct.

### **Thursday, October 20th**

G.R.E.A.T. and Kindergarten tours.

### **Friday, October 21st**

Kindergarten tours

Met with student who wrote a note indicating they should kill themselves. Guidance and staff member met with the student until I arrived. Student did not meet the criteria for a chapter placement and was sent back to class.

Met with a student concerned about problems they were having with another student. One student received a police report that contained information that the other thought should have remained confidential. It was determined this case was not handled by Tomah Police Department but by the State Patrol.

### **Monday, October 24<sup>th</sup>**

Spoke with two students at Tomah Middle School in regards to a telephone and Facebook harassment issue that occurred over the weekend.

Spoke with two Tomah High School students in regards to their behavior in the Alac room and also their behavior that got them there to begin with.

Investigated a harassment complaint with Tomah High School students. This was reported to be occurring in class and on Facebook. Everyone was advised to stop talking to each other.

Assisted patrol with burglary investigation in which a Tomah High School student was taken into custody for burglary, underage alcohol and numerous other charges.

Spoke with a student in regards to being sexual assaulted by her boyfriend in April or May of 2011. Information forwarded to Monroe County Sheriff's Department. Student's father was also advised.

Contact with a Robert Kupper Learning Center student waiting outside of the high school. Tobacco products were removed from the student.

### **Tuesday, October 25th**

Met with a Tomah Middle School student, who had an I-Pod stolen from their locker during the overnight hours.

Meet with a group of boys at Miller School who are having difficulties getting along.



Was advised of a Tomah High School student, who was being uncooperative. Student left the classroom to answer their cell phone and then refused to turn over their cell phone. Student then left school.

Received information of a student, in possession of marijuana. I assisted with a locker search and a search of the student. Student admitted to possession of marijuana and provided it upon asking for it. Student to be cited for municipal possession of marijuana. I also spoke with parent when they picked up the student from school.

Received information of a student in possession of tobacco and darts. Student voluntarily provided them. It was later learned the student commented about using the darts as a weapon. Referral made to district attorney's office for bailjumping. Parent was also advised of this.

Conducted a search of a student for marijuana after it was reported they gave it to the student found in possession of it.

Parent advised her students pants were stolen during gym class. Student was given a police statement to complete. Parent indicated this is not the first time things have been stolen from their student's gym locker.

**Wednesday, October 26<sup>th</sup> Half day of school**

Caught up on reports from earlier this week.

Spoke with a Tomah Middle School student after it was reported they were in possession of an iPod that was not theirs. Student reported it was given to them but would not provide the name of who gave it to them. At this time the iPod has not been reported stolen

**Thursday, October 27<sup>th</sup>**

Search of two students as there was a concern they had been smoking marijuana prior to school.

Served several habitual truancy citations to students.

Follow up with a student in regards to a damage to property complaint.

**Monday, October 31st**

Request for an officer at Tomah Middle School in regards to a disorderly student. Another officer will be referring the student to human services for disorderly conduct. While assisting at Tomah Middle School I was requested back at the high school to search for a weapon. Another officer assisted with the search of the student with nothing

located. After continued investigation and a second search of the student a knife was located. Student will be cited for carrying a dangerous weapon.

Received a statement and lack of consent from a student in regards to stolen iPod. Report taken.

Received a habitual truancy referral.

### TRAINING

Sworn department members received Intoxilyzer recertification training.

Sworn department members participated in Carrying Concealed Weapons updates.

Sworn department members participated in fall firearms qualification.

Chief Revels, Lieutenant Nicholson and Sergeant Weaver attended a Use of Force Workshop.

Lieutenant Nicholson and Administrative Assistant Culpitt attended a Badger TraCS User Update.

Officer Keller attended Street Survival Training.

Officer Walters attended Drug Identification Training.

### CRIME PREVENTION/COMMUNITY RELATIONS

The Department was the lead vehicle in the Homecoming parade.

The Department assisted the Interact leadership group in organizing a Domestic Violence Awareness event to support the Brighter Tomorrow's Domestic Abuse Shelter.

The Department partnered with the United States Drug Enforcement Administration and held another prescription drug take back event.

### INVESTIGATIONS

#### **[11-1845] Disorderly Conduct-Alcohol Related-Physical**

A Tomah Officer was parked in the downtown bar district observing the bar patrons. Two subjects were observed engaged in a physical altercation on the 1100 block of Superior Ave. Contact was made with both subjects and it was determined that only one of the male subjects had been the aggressor. The fight was over one of the male subjects

talking to the other's ex-girlfriend. The aggressor was issued a municipal citation for Disorderly Conduct-Alcohol Related-Physical (\$1,000 forfeiture).

**[11-1964 and 1965] Burglary, Criminal Trespass to Dwelling, Criminal Damage to Property, Underage Alcohol Possession/Consuming, Underage Possession of Tobacco**

Tomah Officer responded to an address on the 500 block of Clark St. for a reported burglary. Officers arrived and began to investigate and gather evidence. A short time later Officers were informed that a citizen had a person inside their residence that didn't belong there. Officers arrived and took a 15-year-old female into custody. This female had a back pack with her that contained property from several different addresses. The investigation revealed that this juvenile was intoxicated and had entered at least seven different homes. The juvenile damaged property at each location, stole numerous items to include prescription medication, electronics, money and jewelry. The majority of the property was located and has been returned to the owner or will be in the future. The juvenile was released to a step-father and will be referred to Monroe County Human Services.

**[11-1978] Disorderly Conduct-While Armed**

Tomah Officers were dispatched to Burger King for a report that a male subject had brandished a pistol and pointed it at an employee of Burger King. Tomah Officers responded to the area and began to search for the suspect. Officers were able to view surveillance footage from Ace Hardware that showed the suspect inside the store prior to the incident at Burger King. Tomah Officers continued searching the area and also began contacting businesses to inform them of the situation and suggest their doors get locked. The suspect contacted Dispatch and stated he was a runaway from a group home, was cold and wanted to speak with the Police. The subject was contacted near Handi-Shop Industries and taken into custody without incident. The subject had the weapon in his waistband at the time he was taken into custody. The subject admitted to buying a "BB" gun from Wal-Mart for personal safety. He was taken to the Monroe County Jail.

**COMMENDATIONS**

On October 29, 2011 the Department participated in the National Medication Drug Take Back Day event. With the assistance of VIPS Program volunteers Dale Chitwood and Joyce Stenklyft, Administrative Assistant Rhonda Culpitt and Lieutenant Mark Nicholson facilitated this event.

Over 300 pounds of medications were processed for disposal.
