CRIME PREVENTION/COMMUNITY RELATIONS

INVESTIGATIONS

[12-2019] Agency Assist – Burglary Suspects

Tomah Officers received a request from the Juneau County Sheriff's Department to attempt to locate two suspects in a burglary in their county. Tomah officers were familiar with both suspects from prior contacts within the City of Tomah. Officers attempted to locate the suspects throughout the day and eventually received a solid lead that both suspects were at an address on Parkview Drive in the City of Tomah. At least one of the suspects is also a suspect in several burglaries in Monroe County, one burglary being the theft of several firearms that were now being sold for drugs. Tomah officers surrounded the residence and were able to take both suspects into custody. The vehicle that was

suspected of being used during the burglary was seized along with property from the residence. Both suspects were transported to the Monroe County Jail.

[12-2020] Felon in Possession of a Firearm

Tomah Officers responded to an address on the 800 block of East Brownell Street for a report of a stolen firearm being in the possession of a known felon. Officers arrived and learned that the suspect did in fact have the firearm but was not at the residence. The father to the suspect was not cooperative and would not provide the location where his son was. Tomah officers were one step ahead and were at another address on the 1500 block of Stoughton Avenue. The father indicated his son was not at this address but officers believed that information was false. A few minutes' later Tomah officers took two subjects into custody at the Stoughton Avenue address. One of the subjects was the suspect officers were looking for. The suspect had a backpack and inside the backpack was the stolen firearm. Both subjects were taken into custody and transported to the Monroe County Jail.

[12-2069] Negligent Handling of Burning Materials

Tomah officers were dispatched to an address north of Dimensions Bar for a reported fire on a back balcony. Officers arrived and located a burning bag of garbage on the roof near an apartment. The officer utilized a fire extinguisher to control the fire until the Tomah Fire Department was on scene. The Tomah Fire Department extinguished the fire. The investigation revealed that two subjects from inside an apartment had discarded lit cigarettes into the garbage. Both subjects were cited and released.

[12-2072] Battery, Disorderly Conduct

A Tomah officer was patrolling the area around the downtown bar district and was flagged down by a female subject behind the Break Room Bar. The investigation revealed the female and her husband were inside the bar and another male subject smashed a beer bottle over the head of her husband. The altercation moved outside and the female subject was punched in the face by the other male. All parties involved have been identified and charges will be referred to the Monroe County District Attorney's Office.
