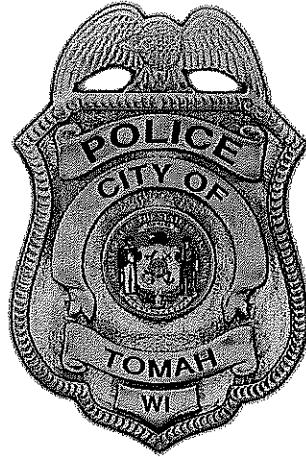

SUPPORT SERVICES LIEUTENANT ACTIVITIES

The following is a list of tasks/assignments/responsibilities carried out in the month of September, 2012 by Lieutenant Ron Waddell:

Shift Supervisor on many scheduled shifts.

Performed Time Agency Coordinator responsibilities including assisting with the creation of a visitor log that is compliant to new Criminal Justice Information Services Security Policy requirements, scheduling of staff Time System renewal/update expectations, the fingerprinting of individuals for "Authorized Access" to the secure areas of the department.

Facilitated the patrol and supervisor training schedules.

Continued weekly checks and cleaning of the drug drop box in the Lobby, to include sorting/storing of received items in the evidence room for accountability.

Attended to all building/facilities issues as required.

As the Evidence Custodian I facilitated return of evidence/found property to owners, and the destruction of certain evidence.

Conducted background check and facilitated scheduling ride-along request.

Provided fleet maintenance oversight and assisted in the scheduling of repairs.

Supervised Field Training Officer Program.

Participated as member of Interview Panel for an entry level patrol officer position.

COMBINED TACTICAL UNIT

Call Out:

No call outs to report in September.

Training:

Training was conducted on September 18 and consisted of three phases: physical agility testing, classroom training and firearms training. Team members conducted a mock physical agility test to allow members an opportunity to assess their level of physical fitness. Beginning in the Spring of 2013 this test will be mandatory for all team members and they must pass the test once per year to remain on the team. Classroom training consisted of Sgt. Weaver bringing up some new ideas for Officer Down – Immediate Action and Shooting Past Other Team Members that he learned at a recent Tactical Team Leader Development training class he attended. Team members were able to discuss some options for these two critical tasks. Lastly, we conducted firearms training and testing at the Tomah Police Department range. Beginning in the Spring of 2013 team members will also be required to pass an annual firearms proficiency test so we conducted a mock firearms proficiency test and then conducted training including practicing the Officer Down – Immediate Action drill several times including as a live fire drill.

TRAINING

Sergeant Holum and Officer Sloan attended the annual Wisconsin Field Training Officer Conference held in Wisconsin Dells. The officers received the most current training techniques specific to the methods our department currently employs for new hires. They also took part in round table discussions that identify issues that occur within other police agencies.

All sworn officers participated in Fall Qualifications with their belt mounted weapon system and the less lethal shotgun.

Lieutenant Waddell and Officer Sloan attended a seminar entitled "Bulletproof Mind" This two day conference was with trainer Lt. Colonel Dave Grossman, who covered such topics as post traumatic stress indicators and management, school and work place violence, survivor guilt, violent visual imagery, and reality vs. fantasy (video gaming desensitization).

Represented Tomah Police Department at the 2012 Wisconsin Alcohol Policy Seminar held in Stevens Point on September 13. While at this seminar I attended break-out sessions/workshops titled "What Makes A Social Host Ordinance" and "Implementing Multiple Policies and Practices To Reduce Alcohol Problems"

CRIME PREVENTION/COMMUNITY RELATIONS

INVESTIGATIONS

[12-1787] Possession of Marijuana, Possession of Drug Paraphernalia, Warrant Arrest

A Tomah Officer was at Walmart Super Center and walked past two males who reeked of burnt marijuana. The Officer had contact with both males and subsequently determined one of them had a warrant. This subject was arrested and marijuana and rolling papers were located in his pocket. Both subjects admitted to smoking marijuana in their vehicle just prior to entering Walmart Super Center.

[12-1789] Battery, Criminal Damage to Property, Disorderly Conduct

Tomah Officers responded to an address on Lori Ave. for a reported disturbance involving a baseball bat. Officers arrived and determined a male subject had arrived home and was immediately confronted by another male subject with a baseball bat who wanted to fight. Both subjects eventually were involved in a wrestling match that took place on the ground. Officers were able to locate the suspect and interview where he admitted to being in the area but not to the details surrounding the use of a baseball bat. The suspect was transported to the Monroe County Jail.

[12-1798] Physical Abuse to a Child, Disorderly Conduct

Tomah Officers responded to the 1300 block of Stoughton Ave. for a reported disturbance. Officers arrived and were invited into the house where they observed two male subjects on the ground; one restraining the other. The investigation revealed that an intoxicated father had struck his son in the face a couple times with a closed fist. The father was arrested and transported to the Monroe County Jail.

[12-1814] **Bail Jumping-Felony, Harassment, Stalking, Unlawful use of a Phone**
Tomah Officers investigated a complaint of a bond violation between and male subject and a female subject. The male subject had domestic related no-contact provisions due to at least one previous altercation. Officers determined that the male suspect had been following the female subject and had begun to threaten the family of the female subject. Officers obtained evidence that resulted in the male subject being located and arrested on numerous felony charges.

[12-1837] **Possession of Prescription Drug without a Prescription, Possession of Marijuana, Possession of Drug Paraphernalia**

Tomah Officers were dispatched to the 600 block of Superior Ave. for a reported disturbance between a male and a female subject. Officers arrived in the area and met with a male subject who was later determined to have been arguing with his girl friend. Officers located six Alprazolam pills on the male subject and a metal pipe used to smoke marijuana. The male subject was transported to the Monroe County Jail.
