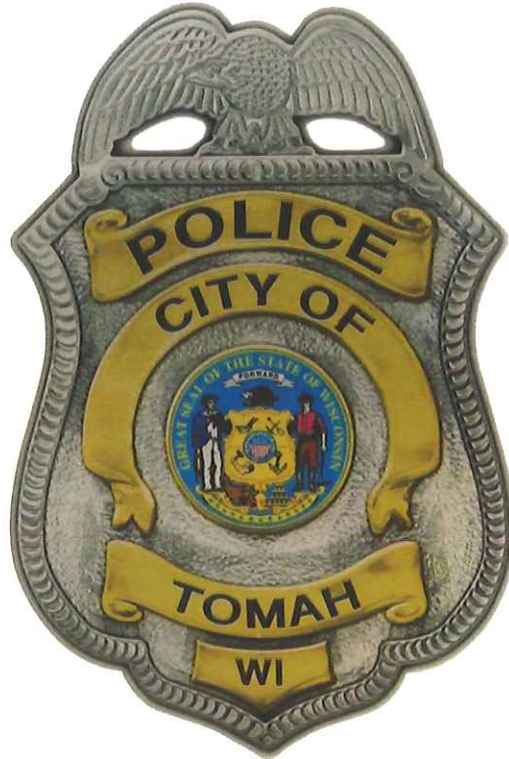

LAW ENFORCEMENT CODE OF ETHICS

As a law enforcement officer, my fundamental duty is to serve the community; to safeguard lives and property; to protect the innocent against deception, the weak against oppression or intimidation and the peaceful against violence or disorder; and to respect the constitutional rights of all to liberty, equality and justice.

I will keep my private life unsullied as an example to all and will behave in a manner that does not bring discredit to me or to my agency. I will maintain courageous calm in the face of danger, scorn or ridicule; develop self-restraint; and be constantly mindful of the welfare of others. Honest in thought and deed both in my personal and official life.

I will be exemplary in obeying the law and the regulations of my department. Whatever I see or hear of a confidential nature or that is confided to me in my official capacity will be kept ever secret unless revelation is necessary in the performance of my duty.

I will never act officiously or permit personal feelings, prejudices, political beliefs, aspirations, animosities or friendships to influence my decisions. With no compromise for crime and with relentless prosecution of criminals, I will enforce the law courteously and appropriately without fear or favor, malice, or ill will, never employing unnecessary force or violence and never accepting gratuities.

I recognize the badge of my office as a symbol of public faith, and I accept it as a public trust to be held so long as I am true to the ethics of police service. I will never engage in acts of corruption or bribery, nor will I condone such acts by other police officers. I will cooperate with all legally authorized agencies and their representatives in the pursuit of justice.

I know that I alone am responsible for my own standard of professional performance and will take every reasonable opportunity to enhance and improve my level of knowledge and competence.

I will constantly strive to achieve these objectives and ideals, dedicating myself before God to my chosen profession . . . law enforcement.

2014 ACHIEVEMENTS

MONROE COUNTY JOINT INVESTIGATIVE TASK FORCE – In 2014 the Tomah Police Department, Sparta Police Department and Monroe County Sheriff's Department joined forces and created the Monroe County Joint Investigative Task Force. Each agency committed one Investigator to be on the Task Force. The mission of the Task Force is to investigate high profile crimes, drug-related crimes that have county wide implications, and/or other crimes where a dedicated group of investigators may increase the probability of solving a serious crime.

PRESCRIPTION DRUG DROP OFF PROGRAM – The Tomah Police Department continues to maintain a Prescription Drug Drop Off Program. Along with the ability to drop off medications throughout the year the Department participated in two nation-wide Take Back Days sponsored by the Drug Enforcement Agency. By participating in the DEA sponsored events we were afforded the opportunity to dispose of our unwanted medication at no cost. The

Department continues to offer a Medication Drop Off Container located in the lobby of the Department for use by citizens who wish to dispose of their unwanted medications. In 2014 we have collected and disposed of over 500 pounds of medication through this program.

MONROE COUNTY DRUG ENDANGERED CHILDREN PROGRAM - In 2014 the Tomah Police Department combined forces with the Sparta Police Department, Monroe County Sheriff's Department, Monroe County Department of Human Services, Tomah/Sparta School Districts, and health care providers throughout Monroe County to form a Drug Endangered Children's Program. Drug Endangered Children Program exists to help make a difference in the lives of children who are in danger because their parents or caregivers are using, dealing or manufacturing drugs. We are united in the commitment to support, rescue, shelter, and defend children who are being harmed by drugs.

CITY OF TOMAH ACTION PLAN, "10 IN 10 LIST" – The Tomah Police Department recognized two key areas in the "10 in 10 List" that directly relate to our Mission Statement. Those areas include #5, "Clean Tomah initiative" and # 8, "Become the safest small town in Wisconsin."

The Tomah Police Department has worked closely with the City Administrator and the City Inspector to update our "Quality of Life" ordinances to provide the officers the ability to assist the City Inspector in enforcing these ordinances. A majority of these ordinance changes directly relate to cleaning up the City of Tomah.

Although there is no single action plan to "Become the safest small town in Wisconsin" we recognize that it is an on-going effort that requires collaboration between law enforcement, schools, social service agencies, civic organizations, businesses, and residents. Our officers are actively involved in activities and organizations, both personally and professionally, to assist in accomplishing this.

MONROE COUNTY NATIONAL NIGHT OUT – The Tomah Police Department continues to be actively involved in organizing and participating in the Monroe County National Night Out event. During 2014 this event was once again held in Tomah at Winnebago Park. It was a very well attended event where citizens have an opportunity to interact with different groups and organizations to address various safety-related issues and community concerns. Along with other activities scheduled at this event is our annual Bike Rodeo. Approximately 230 kids participated in the Bike Rodeo this year.

DEPARTMENT WEBSITE/FACEBOOK – The Department website continues to expand and provide more information and useful links to our community. This website is designed to provide information to the public, as well as housing some forms for the use by the public. The website address is www.tomahpolice.com. The Department utilizes Facebook to provide the community with information.

Currently there are 4,256 "friends" that follow us on Facebook. This number has almost doubled during 2014.

SCHOOL RESOURCE OFFICER, G.R.E.A.T PROGRAM – The Department continues to work closely with the Tomah School District to facilitate the School Resource Officer position and the G.R.E.A.T Program. During 2014 the SRO worked closely with school administration, employees, and students on a daily basis.

WISCONSIN DEPARTMENT OF TRANSPORTATION "CLICK-IT OR TICKET" AND "BOOZE AND BELTS" COMPLIANCE CHECKS – In 2014 the Department participated in the Wisconsin Department of Transportation "Click-It or Ticket" program focusing on seatbelt compliance as well as the "Booze and Belts" program with focus on impaired driving and seatbelt compliance in our community. For participating in these programs the department was randomly chosen to receive a \$4,000.00 grant. The grant will be used to purchase equipment related to transportation safety.

HOLIDAY GIVING TREE – In 2014 the Department partnered with Families First sponsoring our annual "Giving Tree" during the holiday season. The Giving Tree provided Christmas gifts to 35 needy children from our community. In years past we have sometimes had difficulties getting people to participate in this program. This year, within days of setting up the "Giving Tree" almost all of the cards had been removed from the tree.

DEPARTMENT STAFFING - 2014 was a year of organizational change within our department. Along with the hiring of a new Chief of Police the department promoted a Sergeant, a Lieutenant, and hired two new patrol officers. Entering 2015 the department is at full staff.

TEAM BUILDING - In an attempt to work more efficiently and effectively with other City Departments the Tomah Police Department worked closely with the other departments and department directors within the organizational structure of the City. This includes, but is not limited to, those that work in the City Clerk, Parks and Recreation, Ambulance, Inspections, and Public Works departments.

2015 GOALS

PRESCRIPTION DRUG DROP OFF PROGRAM – Beginning in 2015 the U.S. Drug Enforcement Agency will no longer sponsor National Take Back Days which afforded the opportunity for police agencies to dispose of prescription drugs without having to pay for their disposal. The Tomah Police Department recognizes the importance of this program and will explore other options which may assist in offsetting the costs for disposing of the drugs.

COMMUNITY BASED POLICING - The Tomah Police Department's ability to deliver police services through community based policing is part of the on-going partnership we have developed with organizations and groups throughout our surrounding area. Some of those organizations and groups include the following: Our Town Tomah, Monroe County Justice Coordinating Committee, Monroe County Safe Community Coalition, Tomah Financial Institution Security Officers Association, Tomah School District, Tomah Memorial Hospital, Monroe County Child Abuse Task Force, and the Monroe County Coordinated Services Team. In 2015 we will continue to be actively involved in these groups and organizations.

ALDERS AND CONSTITUENTS – The Tomah Police Department will continue to work with any interested Alders in providing information, training and services specific to their districts and constituents. Starting at or near the beginning of 2015 a new monthly report will be generated for the City Council. Although the report will contain less information, it will contain data more relevant to the information which they desire.

POLICIES AND PROCEDURES - A police departments Policy and Procedures Manual is the foundation for all of the department's operations. When properly developed and implemented, a Policy and Procedure Manual provides staff with the information to act decisively, consistently and legally. The department currently has a comprehensive policy manual which allows this to be done. During 2015 the Department will conduct a complete review of its manual. This review will ensure the manual is in compliance with current management, operational and legal standards.

ALCOHOL RELATED ORDINANCES, LICENSE HOLDERS - The Police Department will continue to work with the City Council, the license holders, and the newly formed Alcohol Review Committee to review and reorganize the alcohol related ordinances. The Department will continue to hold meetings with the license holders to address any concerns as they arise. The Department will continue to conduct periodic alcohol compliance checks at the licensed establishments.

PROFESSIONAL DEVELOPMENT - Our employees are our most valuable assets. Training resources and opportunities to learn are critical elements in maintaining a high

level of service for the community. All employees, civilian and sworn, play a vital role in meeting our mission. Preparing future leaders by keeping staff up to date with changing technology, current trends, and forward thinking ideas prepares the department to move into the future. We must continue to invest in their ongoing development to ensure needs are met on the individual and department level. This investment provides a rewarding and healthy work environment which, in turn, drives our employees to seek excellence. In 2015 our department will place an increased emphasis on Professional Development by looking "outside the box" for training which has been traditionally provided. This may include web based training, utilizing State and Federal resources for training not readily available locally, and cross training with other agencies for critical incidents and disasters involving multiple entities.

2014 FIELD TRAINING AND EVALUATION

The Field Training and Evaluation Program is a sixteen-week process that is designed to train a new employee, or Probationary Officer, to become a fully competent police officer. During this period, the Probationary Officer is assigned to a Field Training Officer and is evaluated on his or her performance each day. The Field Training Officer also provides the Probationary Officer with instruction, direction, guidance and assistance each day they are working together. The common goal is for the Probationary Officer to successfully complete the program, which would allow him or her to function on his or her own, or “solo patrol.”

The Field Training and Evaluation Program is broken down into five steps, with each step lasting four weeks. During Step I, the Probationary Officer is assigned to his or her Primary Field Training Officer. The Probationary Officer is then assigned to other Field Training Officers for Steps II and III. The Probationary Officer is then reassigned to his or her Primary Field Training Officer for Step IV. Once the Probationary Officer successfully completes Step IV, he or she is elevated into Step V. Step V is “solo patrol” and lasts for the duration of the officer’s Probationary Period, which is twelve months. After the twelve-month period, the Probationary Officer will be granted tenure with the department if he or she has displayed an ability to function as a competent police officer. The Field Training and Evaluation Program is designed for success. Structured training and evaluation of the Probationary Officer is designed to produce a desired result, which is a police officer that is an asset to the Tomah Police Department and to the citizenry of Tomah.

The Field Training and Evaluation Program is commanded by Lieutenant Scott Holum and supervised by Sergeant Eric Pedersen. The Field Training Officers are Officer Brittney Westpfahl, Officer Aaron Hintz and Officer Will Steinborn.

Officer Tyler Franks (June 22, 2014) and Officer Nicholas Gimson (August 31, 2014) were hired by the Tomah Police Department in 2014. Officer Tyler Franks and Officer Nicholas Gimson have completed the Field Training Program and are currently on solo patrol as a Probationary Patrol Officers until June and August of 2015, respectively.

2014 INVESTIGATOR'S ANNUAL REPORT

ARMED ROBBERY

February 6, 2014 patrol units were dispatched to 1321 North Superior Avenue for a subject being held hostage. A male subject contacted the Monroe County Communication Center advising he was being held hostage and to track his phone. The male subject mentioned something about a U-Haul rental center. A 9-1-1 phone trace was conducted via dispatch which was able to put the phone in the area of 1321 North Superior Avenue. A perimeter was established and contact was made with the male caller. Another male subject was taken into custody and a black Magnum Research BB gun (facsimile firearm) was recovered. A short time later, officers located the suspect and he was taken into custody. The victim reported that one of the suspects called him and asked for a ride to his doctor's appointment at the VA Hospital. The victim went to 1321 North Superior Avenue. The victim informed the suspect he was leaving and asked the suspect if he wanted a ride. The suspect left the residence via the backdoor and was gone for about five minutes and when the suspect returned he had a handgun. The suspect asked the victim where his money was at. The victim stated the suspect loaded the gun and put it up to his face. The suspect struck the victim above his right eye, right cheek and above his upper lip with the barrel of the gun. The victim was also struck on his left temple with the butt of the gun. At the time of the incident the victim believed the gun was real and that he was going to die. While the suspect hit the victim with the gun he also demanded money from the victim. The victim plead with the suspect telling him they had been friends since sixth grade. The suspect took the victim's cellular phone from his hands and threw it and then started checking the victim's sweatshirt pocket and front jeans pockets for money. The suspect did not locate any money in the victim's front pocket. After not locating any money, the suspect went to search the victim's car. The victim said while the suspect was outside the residence he removed an estimated \$400 in cash from his right rear jeans pocket and placed it in a plastic grocery bag, which was hid in his pants. Once the suspect returned inside he started cursing and yelling at the victim. The victim said he tried to leave the residence several times and when he did so the suspect would pull him back and would then throw him down in a chair. The victim stated the suspect still had the gun and would point it at him. The suspect informed the victim that if he called 911 neither one of them would come out alive. The suspect left the residence a second time and the victim was able to call 911. The suspect retrieved a zip lock bag containing approximately \$50 in coins from the victim's car. The suspect reentered the house and struck the victim with the bag of money and checked his rear pants pockets. After not finding any money, the suspect agreed to allow the victim to leave to get money for him, but another subject was going to accompany him. When the victim and other subject exited the residence they were confronted by the police and the second subject had the gun in his front waistband. The suspect was arrested and booked into the Monroe County Jail for Armed Robbery, Taking Hostages, False Imprisonment, and Battery. Incidentally, the suspect in this case died later in 2014 from a heroin overdose.

COCAINE DELIVERY

On March 24, 2014 a confidential informant was in contact with a subject who was waiting for someone to call him back to see if any base cocaine was available for the confidential informant. The confidential informant was put in contact with a third party. Based on text messages, arrangements were made for a drug transaction to occur at an apartment in the City of Tomah. The confidential informant was searched and provided with cash to purchase cocaine. A short time later a red Dodge Intrepid pulled up nearby and it was suspected that this vehicle was involved. The vehicle then proceeded to turn into the lot and pulled up near the apartment. Two male subjects entered the apartment and sold cocaine to the confidential informant. The two suspects that entered the apartment got back into the vehicle after selling cocaine. Tomah Police observed the vehicle leave and verified that the drug transaction occurred. The vehicle was stopped by police and the subjects were arrested. One of the occupants stated that one of the males that sold the cocaine was a friend of her son and paid her \$15.00 to give him a ride to Tomah. When they got to Tomah the suspect met someone and they picked up the second suspect that sold the cocaine who directed them to the apartment. The local suspect that was picked up by the other subjects and assisted in selling the cocaine at the apartment told police that the suspect from Lacrosse sold crack cocaine to the occupant of the apartment and also that the Lacrosse suspect had "more crack cocaine in his ass right now." A search of the Lacrosse suspect was done. The suspect had a cellular telephone and \$260.00 in cash, none of which was the buy money from this case. The Lacrosse suspect had a tube in his stomach for kidney dialysis and had a band around his stomach that held the tube in place. The cash and cellular telephone were seized. A plastic bag of crack cocaine was recovered from the buttocks of the Lacrosse suspect. The police buy money was located in the back pouch of the passenger side seat in the vehicle, directly in front of where the Lacrosse suspect was seated in the vehicle. Both suspects were charged with felony drug charges related to the delivery of crack cocaine in this case.

HEROIN DELIVERY

On March 30, 2014 and March 31, 2014, heroin was purchased from two suspects who had recently been released from prison from the Dane County area. One of the suspects did have ties to the Tomah area. The first heroin delivery occurred in a city park, and the second two heroin deliveries occurred in an apartment in the City of Tomah. The plan after the third delivery was to arrest the subject who delivered the heroin. The suspect delivered the heroin and then left the area in a vehicle with a female subject driving. When officers stopped the vehicle, the suspect and the passenger in the vehicle fled from the vehicle into a nearby residence. This subject eventually came out of the residence after a period of time and was taken into custody. It was determined that the second

suspect related to the heroin deliveries over the past two days was also in the residence. Eventually, the second suspect exited the residence and was taken into custody. A search of the residence was done and additional evidence of the heroin deliveries was located, along with some marijuana. Two subjects at the residence were charged with marijuana related crimes. A search was also done related to this investigation at a Douglas Avenue residence near Valley Junction. Heroin and marijuana were also recovered at that residence. The two suspects that were involved with delivering heroin over a two day investigation were arrested and charged with felony charges related to the heroin deliveries. Three other subjects were also charged with criminal charges related to the marijuana and drug paraphernalia that was located in the two residences that were searched.

POSSESSION WITH INTENT TO DELIVER HEROIN

On April 19, 2014 officers responded to Walmart for a report from Walmart Asset Protection that there were three subjects inside the store that were concealing items. Contact was made with a male subject involved outside the store. As officers made contact with the first male subject, Asset Protection pointed out a female that was exiting the store that had also been concealing items. Contact was made with the female. The female stated that she had stolen some items and had placed them in her purse and pulled five or six items from her purse that appeared to be brand new. The items consisted of some random household items and two pairs of sunglasses. The female was on three sets of misdemeanor bonds out of Monroe County. A third person, male, was pointed out by Asset Protection as being with the other two detained suspects. The third suspect was contacted and detained. The subjects were arrested and were in possession of drug paraphernalia. Asset Protection also stated that one of the suspects had made a previous trip from the store to a vehicle that was parked in the parking lot. It was determined that the vehicle was parked nearby and was registered to one of the suspects. Drug paraphernalia was located in the vehicle and one of the suspects was in possession of a large amount of cash. Heroin was also located. One suspect was charged with felony charges related to the heroin and drug paraphernalia. The two others were charged with criminal charges for the theft and other drug related charges.

DEATH INVESTIGATION

On July 1, 2014 a male in his twenties was found deceased at a Tomah residence. The scene was processed and it was believed that heroin was possibly the cause of the death of this individual. The investigation led to the Necedah area and a search warrant was executed at a motel room in rural Necedah. Heroin and drug related items were located in the motel room. An autopsy confirmed that heroin overdose was the cause of the death of this person. The subject from the Necedah motel was cooperative with the investigation and it was determined that the subject from Necedah had delivered heroin to

two subjects in Tomah the night before the death of this person. The heroin from the subject from Necedah was determined to be the heroin that the deceased subject in Tomah had used before his death. The subject from Necedah has been charged with reckless homicide in this case.

2014 SCHOOL RESOURCE OFFICER ANNUAL REPORT

Officer Marshall provides law enforcement and police services to the schools in the City and enforces state and local laws as needed. Truancy, disorderly conduct and drug violations are just a small list of the different types of calls that Officer Marshall handles.

Officer Marshall continues to maintain a close partnership with school administrators in order to provide a safe school environment. Officer Marshall assists administrators by being present during school searches which may involve weapons, controlled dangerous substances, or in such cases that the student's emotional state may present a risk to the administrator. Officer Marshall also assists in emergency crisis planning and building security matters. Officer Marshall works closely with the school district in regards to the safety and security of the schools and students in the district.

Officer Marshall is visible within the school community by attending and participating in a variety of school events throughout the year. Student Orientation, Child Development Day, Prom, and Homecoming Week are just a small number of events that Officer Marshall participates in. Officer Marshall speaks in high school Health and Teen Parenting classes, and is available to other classes as requested.

Officer Marshall teaches G.R.E.A.T. throughout the school year to sixth grade students at Tomah Middle School and St. Mary's School. She also provides tours of the police department to elementary students upon request.

Officer Marshall serves as a resource for both the staff and students and continues to build relationships with both groups. Students are able to meet with Officer Marshall in regards to any concerns or questions they may have. Staff members share information with Officer Marshall in regards to concerns they may have about students. Officer Marshall meets with the principals and guidance counselors at the high school on a regular basis for information sharing and concerns. This is necessary in order to assist students and provide services to students involved in situations where referrals to social service agencies are necessary.

Officer Marshall assists other officers and agencies with coordinating interviews or services that involve students within the school district. Officer Marshall has regular contact with workers from Monroe County Human Services in regards to concerns that involve students and families. Officer Marshall also assists Intensive Sanction Program workers with the students that they monitor.

Officer Marshall maintains communication with other officers that have had interactions with students or staff and keeps abreast of any pending investigations involving students or staff from the school district

2014 K-9 UNIT ANNUAL REPORT

The Tomah Police K-9 Unit consists of Officer Aaron Hintz and his partner, K-9 Jager. Officer Hintz has worked for the Department since September 2005 and was selected as the K-9 Handler in 2009.

In June of 2009, Officer Hintz traveled to Sanford North Carolina and visited Tarheel Canine Training Inc. Officer Hintz was able to look at several dogs and ultimately selected K-9 Jager. K-9 Jager is a male sable German Shepherd Dog that came from the Czech Republic. Officer Hintz traveled back to Tarheel Canine in September of 2009 for 4 weeks of training with K-9 Jager. Officer Hintz and K-9 Jager successfully completed training together in a variety of different areas.

Officer Hintz and K-9 Jager work together on 1st shift, but are also on-call to assist members of the Department with situations where K-9 Jager could be of assistance. Officer Hintz and K-9 Jager are also members of the Monroe County Combine Tactical Unit (CTU). K-9 Jager is a dual-purpose patrol dog. The term “dual-purpose” suggests two jobs; this is somewhat deceiving. First, K-9 Jager is trained as a patrol dog, providing handler protection, criminal apprehension, tracking, building searches and area searches. Secondly, K-9 Jager is also trained as a drug detector dog. He is trained to detect and alert to the odor associated with marijuana, cocaine/crack, methamphetamine and heroin. In addition to these trained jobs, K-9 Jager serves as a community relations tool for the Department.

Officer Hintz and K-9 Jager train together on a regular basis in order to stay proficient in the different tasks K-9 Jager is trained to perform. Most recently, in early October 2014, K-9 Jager and Officer Hintz were certified through N.A.P.W.D.A. in all the areas K-9 Jager is trained in.

2014 CASE HIGHLIGHTS

Drug Sniff - Vehicle: K-9 Jager and Officer Hintz conducted an exterior sniff on a vehicle after they had received a tip that it might be involved in drug activity. In the process of conducting the sniff K-9 Jager stopped and alerted to a baggie of marijuana that had been thrown under the vehicle in an attempt to hide it by one of the occupants. K-9 Jager also alerted on the vehicle. Additional drug paraphernalia was located in the vehicle.

Community Relations: Officer Hintz conducted a K-9 Presentation/Demo to the Cub Scouts. Officer Hintz explained to the Cub Scouts the different ways K-9 Jager helps the police do our job. Officer Hintz took questions from the Cub Scouts and helped them understand what K-9 Jager is capable of. Officer Hintz did a narcotics demo where K-9 Jager located and alerted to one of six boxes present. Officer Hintz did an apprehension demo with Lt. Waddell where K-9 Jager apprehended him and then released and came back to Officer Hintz. K-9 Jager stayed in a down position while Officer Hintz conducted a pat-down of Lt. Waddell until Lt. Waddell simulated assaulting Officer Hintz. K-9 Jager broke from his position and immediately apprehended Lt. Waddell, protecting Officer Hintz.

Patrol: Officer Hintz and K-9 Jager, together with the Tomah CTU members and Investigator Walensky assisted U.S. Marshalls with locating and taking a suspect, who was known to run, into custody on a Pennsylvania warrant for attempted homicide. Officer Hintz and K-9 Jager held a position on the suspect apartment on the corner of the apartment under the second story windows. Shortly after the other officers went to the apartment door they called for Officer Hintz and K-9 Jager to move to the apartment. Officer Hintz provided cover with K-9 Jager from the doorway while the suspect was taken into custody. The suspect told the U.S. Marshall's later that the only reason he did not run was because of K-9 Jager. K-9 Jager provided a level of cover and also would have been essential if the suspect would have tried to run from officers.

Drug Sniff /Agency Assist - Vehicle: Officer Hintz was requested to respond, while off duty, to assist at a traffic stop a Monroe County Sheriff's Deputy had conducted. Officer Hintz deployed K-9 Jager and conducted an external sniff which resulted in a positive alert by K-9 Jager. While K-9 Jager was searching the interior of the vehicle he was sniffing an open and partially full can of fruit flavored energy drink. In the process of

sniffing and alerting on the can K-9 Jager knocked it out of the cup holder and onto the seat. K-9 Jager stayed with the can and Officer Hintz looked inside the can to see what appeared to be a plastic baggie. It was determined a few minutes later that the plastic baggie in the can contained marijuana.

Patrol Cover – High Risk Traffic Stop: Tomah Police received information and a request to assist the Monroe County Joint Investigative Task Force in taking a wanted subject into custody. The suspect was supposed to be arriving in the city to make a drug transaction and was possibly carrying a handgun. Officers conducted a high risk traffic stop on the suspect vehicle once it arrived in the city. K-9 Jager provided cover while staying in down and heel positions alongside Officer Hintz. K-9 Jager's level of discipline and obedience allowed Officer Hintz to utilize his patrol rifle with K-9 Jager simultaneously. K-9 Jager was a great physical, and more importantly, psychological deterrent from the suspect running, as well as enforcing compliance from the occupants of the vehicle. The occupants were taken into custody without incident.

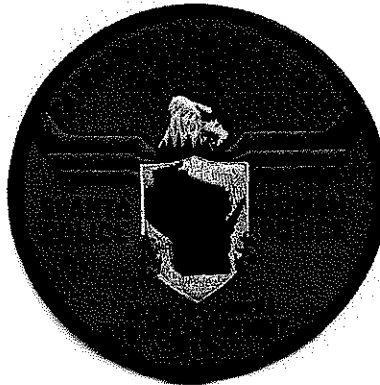

The Monroe County Combined Tactical Unit (CTU) is a Multi-Jurisdictional SWAT Team staffed by members of the Tomah Police Department, Sparta Police Department and Monroe County Sheriff's Department. The member agencies have entered into an agreement to staff the team in this manner to allow for the most efficient use of each department's resources.

The Tomah Police Department, acting on behalf of the Monroe County Combined Tactical Unit (CTU), completed the application process to receive a Mine Resistant Ambush Protected (MRAP) armored vehicle. We were fortunate enough to be selected to receive an MRAP after the competitive selection process. The fact that we have a multi-jurisdictional SWAT team was beneficial, as was our history of cooperation with surrounding area tactical teams. The MRAP was delivered on May 30; within six hours of delivery we put the vehicle into use at a Barricaded Suspect callout in Sparta. Armored vehicles have become an important piece of equipment in present day SWAT tactics. During the May 30 callout the lack of cover on the rear of the residence required that we request assistance from the La Crosse County Sheriff's Department Emergency Response Team in the form of their BEARCAT armored vehicle.

2014 INFORMATION TECHNOLOGY ANNUAL REPORT

The following enhancements or upgrades were made in the area of Information Technology or Electronic communications;

Two new Mobile Data Computers were purchased to replace outdated units. One unit was paid for by a Department of Transportation grant.

2014 COMMUNITY SERVICES ANNUAL REPORT

In 2014 the members of the Police Department were again busy with a variety of community service activities that involved various organizations and people of different ages throughout the community.

National Night Out

Together with the assistance of Tomah Memorial Hospital, Walmart Super Center and the Walmart Distribution Center, the 12th Annual Monroe County National Night Out was held at Winnebago Park. Organizations from around the area were invited to showcase resources available to the community that make Monroe County a safer place to live, work and play. The event was well attended by organizations and the public.

The Police Department's Bike and Blading Safety Expo was also held in the park during National Night Out. Demonstrations were conducted by the Monroe County Tactical Unit, the Town of Lincoln Fire Department and First Responders, Tomah Fire Department and Rescue Technicians, Tomah Area Ambulance Service and the Oakdale First Responders and Fire Department.

Members of the Tomah FFA chapter displayed an animal learning center and also kept children busy with games and activities.

This event would not be possible without the support of and donations from the local businesses and civic organizations.

Bike and Blading Safety Expo

The Police Department held its annual Bike and Blading Safety Expo in conjunction with National Night Out at Winnebago Park. Volunteers from all over the county came together to help make the course run smoothly.

During the Bike Rodeo participants are invited to ride or blade through a variety of safety/obstacle courses. Free bike registration is also available on that evening.

Monetary donations from area businesses and community members, together with a grant from Wal-Mart, assisted us in purchasing bikes and back packs for children who participated. Each child who participated was given a back pack filled with basic school supplies. Over 200 children attended the bike rodeo.

Tours

Throughout the year the Department provides tours of the Police Department to different community groups such as the Boy Scouts and Girl Scouts.

The Department provides tours to groups who request a tour.

School District Events

Each year the Police Department participates in Child Development Day sponsored by the Tomah School District. The Department provides information in regards to child safety issues, including car seat safety. Child fingerprinting is also provided to the children.

At Tomah Middle School and St. Mary's School Officer Marshall teaches G.R.E.A.T. to sixth grade students.

Upon request, members of the Police Department provide information to the students and staff at Tomah High School. Topics range from traffic enforcement, child safety seats, drug identification, search and seizure and critical incident responses.

Car Seat Safety Inspections

Officer Marshall, together with trained officers from the Monroe County Sheriff's Department and staff from Tomah Memorial Hospital, provide free car seat safety information and safety inspections throughout the county. Information is passed out and parents are instructed on the proper and safe way to travel with their children. Car seats are also available to purchase at cost, or in the case of financial need, they are provided to families for a minimal charge.

The Monroe County Health Department received a state grant in which they purchased car seats and provided them to families who received county support services. Officer Marshall assisted with the distribution and installation of some of the seats.

Officer Marshall receives requests from parents every week in regards to car seat safety and safety seat inspections. Without the financial support of numerous organizations we would not be able to provide car seats to the public.

Officer Marshall attends specialized training session each year in order to maintain her certification as a certified car seat technician.

Child Fingerprinting

With the assistance of the Tomah Lionesses, the Police Department provides child fingerprinting free of charge. Throughout the year parents are able to have their child's fingerprints placed in an identification kit that they can complete. This kit also includes photographs, dental records and a hair sample. Fingerprinting was provided at various events throughout Monroe County during the year.

Monroe County Safe Community Coalition

The Department participates in the county wide effort to promote safety related to driving while under the influence, speeding, seat belt usage, bicycling and skateboarding. The Coalition also works towards reducing youth smoking and underage alcohol consumption.

Tomah Business and Industry Committee

Tomah Memorial Hospital Community Outreach coordinates this committee. The committee meets every two or three months and is made up of representatives from Tomah Businesses and Manufacturers. Issues such as employee wellness, workers compensation, workplace safety and employee health are all discussed.

Monroe County Justice Coordinating Committee

This committee consists of representatives of the various segments of the Criminal Justice System: Probation and Parole, Victim Witness, Judiciary, Law Enforcement, Public Defenders Office, Jail Administration, Human Services and others. The committee discusses issues related to family court, day reporting center, jail ministry, jail program coordination, mental health services, 911 central dispatch, courthouse facility planning and other areas.

Tomah Memorial Hospital Events

Each year Tomah Memorial Hospital hosts various health/safety wellness events. In 2014 officers attended the Senior Citizen and Men's Health and Safety Expo. Officers attend these events and provide safety information to the community..

Others

Over the last several years Gunderson Lutheran Clinic has hosted a Family Safety Night. Officer Marshall attended in 2014 to pass out safety information to families.

The Police Department receives a variety of requests in regards to community education topics. There are requests for information about identity theft, internet safety, stranger danger and numerous other topics. The Department works hard to accommodate the requests to the best of their abilities. Anyone with a special request is welcome to contact the police department.

2014 GANG RESISTANCE EDUCATION AND TRAINING (G.R.E.A.T.) ANNUAL REPORT

The spring of 2014 was the completion of the fourth year of teaching G.R.E.A.T. to 6th grade students at Tomah Middle School and St. Mary's School. Approximately 200 sixth graders from Tomah Middle School and Saint Mary's School completed the program. As part of the G.R.E.A.T. Program graduation requirements students need to be involved in some sort of community service project and share what they did to benefit their community. Upon completion students were awarded with a G.R.E.A.T. certificate and back pack.

The G.R.E.A.T. Program is taught to all 6th graders at Tomah Middle School during their Health class and is taught at St. Mary's during free periods. The program consists of G.R.E.A.T. lessons that cover various topics such as goal setting, decision making, active listening, conflict resolution, dealing with peers, anger management and being part of the community.

Sgt. Huneck assists Officer Marshall with the G.R.E.A.T. Program by teaching classes when Officer Marshall is unable to do so.

Officer Marshall is currently teaching G.R.E.A.T. to sixth graders at Tomah Middle School and St Mary's School.

2014 GRANTS AWARDED

During 2014 the Tomah Police Department applied for several grants. Throughout the year the police department was awarded \$18,163.00 worth of grants. The following is a list of grants, the amount received from the grant, and how the money that was received was or will be used.

\$6,000 was received from the Andres Grant. \$2,500 was used to facilitate the G.R.E.A.T. Program at the Tomah Middle School as well as to support other crime prevention initiatives. \$3,500 was used to update/purchase three new Automated External Defibrillators.

\$884 was received from the Edward Byrne Memorial Justice Assistance Grant to offset purchases that were made for bullet proof vests.

\$525.00 was donated to the department by a citizen who requested to remain anonymous. This donation was used to purchase a new body worn video system for the officers.

\$1,084 was received from the Wisconsin Department of Justice Internet Crimes Against Children (ICAC) program. This grant was used to purchase a laptop computer to investigate ICAC cases.

\$4,170 was donated to the police department by various businesses, organizations and individuals. These donations were used to facilitate the Bike Rodeo held during Monroe County National Night Out.

\$4,000 was awarded from the Wisconsin Department of Transportation for our involvement in the Click It or Ticket and the Booze and Belts programs. (see below)

\$1,500 was received from the Walmart Foundation. These monies were used to pay for the LeadsOnline program. This program allows law enforcement access to pawn shop information.
