April 2014 Report

CHIEF'S ACTIVITIES

The following is a list of tasks/assignments/responsibilities carried out in the month of April 2014:

I assisted in the weekly monitoring of the Prescription Drug Drop Off Box located in the lobby of the Tomah Police Department.

April is National Child Abuse Prevention Month. As such, I attended a meeting to promote and declare April as Child Abuse Prevention Month. This meeting was held in Sparta and attended by other law enforcement agencies, school members, prosecutors, judges, child advocates and members of the public.

Throughout the month of April I met with several Licensed Agents of businesses in Tomah that failed the recent Alcohol Compliance Check that was conducted. Information was provided to them in an attempt to educate and encourage them to provide instructions to their employees about the need to confirm ages of those purchasing alcohol.

I attended a voluntary meeting for Licensed Agents/Owners of businesses in Tomah that sell alcohol. The meeting was attended by 15 local businesses, members of the City Council and City Clerk JoAnn Cram.

I attended a meeting with Monroe County Communication Director Randy Williams to discuss issues or concerns each agency has with specific incidents that have occurred.

I attended a meeting with representatives from CenturyLink to discuss and gather information about a new telephone system. A subsequent meeting was held with City Administrator Gorius, City Clerk Cram and City Treasurer Rusch to discuss the same. A meeting has been scheduled for CenturyLink to provide a demonstration of the product that they have for all department heads to view.

I attended a meeting with Our Town Tomah.

Lt. Waddell and I chaperoned the After Prom Party held at the Ho-Chunk Cinema. This event was held from 11p.m. until 6:30 a.m. Approximately 150 students attended the event.

I attended a Monroe County 911 Advisory Board Committee meeting. Those in attendance included EMS, Fire, Law Enforcement, and Communication agencies.

I attended a Combined Tactical Unit Executives meeting. This meeting is held quarterly. Those in attendance included members of the Sparta, Monroe County, and Tomah police agencies. Topics discussed included training, equipment, and

recent callouts. Also discussed was allowing other police agencies in Monroe County onto the CTU team.

I assisted in the facilitation of the departments Social Media Networks to include Facebook and Twitter.

I attended bi-weekly meetings with the other Department Supervisors.

I attended and chaired the Administrative Staff meeting between Lt. Waddell, Lt. Holum, Administrative Assistant Culpitt and myself.

I attended a Police and Fire Commission meeting to discuss with the Commission the current job openings to include the Lieutenant, Sergeant, and Patrol Officer positions.

Chippewa Valley Technical College asked that I assist with their recruit academy interview process. Along with several Chiefs and Sheriffs from around the area I assisted by interviewing perspective cadets/recruits who were seeking admission into the Law Enforcement Recruit Academy.

OPERATIONS LIEUTENANTACTIVITIES

The following is a list of tasks/assignments/responsibilities carried out in the month of April 2014 by Lieutenant Ron Waddell:

With the promotion of Lieutenant Holum, I have assumed all Lieutenant of Operations responsibilities. Inclusive to these assignments are departmental scheduling issues (overtime, time off requests, special assignments).

Facilitated responsibilities as the Time Agency Coordinator (TAC), scheduling on-line recertification and conducting expiration audits.

Performed oversight on all building maintenance issues, to include work orders, accounts payable approvals, etc.

Assisted with the copying of Open Record Requests for DVD, VHS and CD's as needed.

I conducted shift supervisor activities on many of my regularly scheduled shifts and was available for incident command/high risk calls

I monitored the Prescription Drug Drop Box located in the lobby of the Tomah Police Department, which seems to average a full box every 1.5 weeks. The National Drug Take Back Day was held April 26^{th} from 10 a.m. -2 p.m. Two (2) boxes, averaging between 40-50 pounds each, were collected on that day. We also maintained eight (8) full boxes that had been collected over a six month period from our lobby drop box that is available for disposal during normal

business hours. Lieutenant Holum transported the boxes of unwanted or expired medications to a drop site in Deforest, Wisconsin.

I monitored and processed incoming temporary evidence as needed. The evidence responsibilities also required return of evidence and limited destruction of evidence as time permitted. Evidence was provided to officers for follow-up and/or turn over to other police agencies.

Fleet maintenance oversight continues with scheduled and unscheduled repairs.

Chief Nicholson assigned me to participate in the monthly City Safety Committee meetings. The focus of this committee is to make city employee work environments as safe as possible through risk management analysis, and ultimately, through policy change. The proactive measures, when followed, should provide an appropriate nexus to reduce worker's comp claims.

As a result of a recent Memorandum of Understanding involving our department, the Tomah Area School District and Monroe County Social Services, each are better able to share information involving at risk youth that are receiving services, or may need services offered. I, along with Officer Marshall, participated in a meeting with each of the aforementioned organizations. Excellent concept just getting underway.

Chief Nicholson and I chaperoned the After Prom Party held at the Ho-Chunk Cinema. This event was held from 11p.m. until 6:30 a.m. Approximately 150 students attended the event.

I attended an Administrative Staff Meeting with Chief Nicholson, Lieutenant Holum and Administrative Assistant Culpitt.

SUPPORT SERVICES LIEUTENANT ACTIVITIES

I scheduled the department for Spring firearms qualification that will take place in May.

I, along with Lieutenant Waddell and Administrative Assistant Culpitt, scheduled the upcoming Patrol Officer hiring process. The candidates will take a Physical Agility Test, Written Test and PEP Exam on May 3rd. Command Staff Interviews will take place on May 19th.

I scheduled and secured the location for the Physical Agility Test through the Tomah School District.

I was provided training by Chief Nicholson and Lieutenant Waddell on various administrative tasks, to include Training and Evidence.

I continued to coordinate the Uniform Allowance program for each sworn member of the police department.

I reviewed submitted information from the patrol staff that are interested in a promotion to Sergeant of Police.

I transported the prescription medication collected during the National Pharmaceutical Take-Back Initiative to the DEA drop-off point in DeForest, Wisconsin.

COMBINED TACTICAL UNIT

COMBINED TACTICAL UNIT CALL OUT:

None to report.

TOMAH POLICE DEPARTMENT TACTICAL CALL OUT:

04/01/14 – Over the course of two days Tomah Police Department personnel including drug investigators and tactical personnel conducted three controlled buys of heroin from a suspect who was recently released from prison after being convicted of dealing cocaine after a previous Tomah Police Department investigation. Tactical team personnel assisted in covert surveillance of the suspect's residence, surveillance of the drug buys, and ultimately the arrest of two suspects who were selling heroin. One suspect was followed to a family member of the other suspect's house. Both suspects went into the house where other family members, including small children were present. Tactical team members surrounded the house and worked with the family members to retrieve the small children and a dog from the residence. Once un-involved people were safely out of the residence the tactical team members began communications with the two suspects and both eventually exited the residence and were arrested.

04/03/14 – Tomah Police Department tactical personnel assisted with a controlled drug buy-bust. After the drug buy was completed two tactical team members followed the suspect until a uniform officer in a marked police vehicle conducted a traffic stop on the suspect vehicle. Tactical unit personnel assisted with the high risk traffic stop and the suspect was arrested without incident.

04/11/14 – US Marshal's Office Personnel requested assistance from Tomah Police Department in apprehending a suspect wanted for Attempted Homicide in Pennsylvania. Tomah Police Department tactical unit officers assisted the US Marshal's Office with conducting surveillance in the area of the suspect's address and also with contacting the occupants of the suspect's apartment. The suspect was located and arrested without incident.

TRAINING:

Training was conducted in Sparta and consisted of a meeting and training session beginning at the Sparta Police Department. Sparta Police Officer Guralski and Tomah Police Officer Jones, Combined Tactical Unit snipers, provided classroom instruction on sniper deployment and camouflage techniques. Tomah Police Sgt. Weaver and Sparta Police Officer Nelson provided a briefing on FBI SWAT training that was conducted at Fort McCoy. The second portion of training was conducted at Southside Elementary School and consisted of building clearing exercise including evaluating some of the tactics/techniques/procedures from the FBI. Some of the tactics/techniques/procedures were determined to be beneficial and will be integrated into our standard operating procedures and other tactics/techniques/procedures were discarded.

INVESTIGATIONS

[14-0458] Heroin Delivery, Possession of Cocaine, Possession of Marijuana

Tomah Police Department personnel were involved in the controlled purchase of heroin and cocaine. This operation culminated in the arrest of two subjects for their respective involvement. Following a final purchase of drugs, Officers had contact with several people at an address on the 1200 block of Glendale Avenue. Tactical personnel were used to surround and methodically control the actions of all personnel at this location. Ultimately, several subjects and a couple children were removed from the residence before officers were able to arrest the two suspects. The two suspects were transported to the Monroe County Jail.

[14-0499] Agency Assist

Tomah Police Department tactical personnel assisted the US Marshall's Office with locating a wanted felon for Attempted Homicide in the State of Pennsylvania. Tomah officers and the US Marshall's Office personnel had information that the suspect may be at an address on the 400 block of North Glendale Avenue. Law enforcement personnel went to a known address and located the wanted subject. The wanted subject was taken into custody without incident. While at this location, Tomah officers located items of drug use and charges will be forwarded to the Monroe County District Attorney.

[14-0505] Bail Jumping-Felony, Possession of Drug Paraphernalia, Possession of Marijuana, Urinating in Public

Tomah officers were patrolling the downtown bar district and observed a male subject urinating on the sidewalk. Officers had contact with two subjects, both of which are currently on bond conditions. The subject who was urinating was on bond prohibiting the consumption of alcohol. This subject was clearly intoxicated and was taken into custody. The other male subject attempted to hide drug paraphernalia in a vehicle and was taken into custody. Both subjects were transported to the Monroe County Jail.

[14-0506] Disorderly Conduct-Alcohol/Physical

Tomah Officers responded to Franny's Bar for a reported fight in progress. Officers arrived and contacted two male subjects who were involved in the fight. Officers learned that the argument started in the bar and another patron removed one of the subjects. Once outside the other subject came out and continued the fight. Both subjects engaged in a physical fight that resulted in both of them being cited municipally and being released.

[14-0520] Substantial Battery, Recklessly Endangering Safety

Tomah officers responded to an address on the 300 block of Hollister Avenue for a reported disturbance. Officers arrived and met with a juvenile female and her father. Officers learned the juvenile had called the Police to report that her parents were fighting and that her mother was unconscious. Officers located an adult female victim in an upstairs bedroom. The female was unconscious but had a pulse and labored breathing. An ambulance was summonsed immediately. The male subject admitted to arguing with his wife and at one point they both "Fell" to the ground at which point he believed she was rendered unconscious. A neighbor observed the male subject throw his wife to the ground at least twice. The male subject was taken into custody and transported to the Monroe County Jail. The female subject was transported to Tomah Memorial Hospital where she was eventually transported to La Crosse for further medical treatment. The female didn't regain consciousness while in the City of Tomah. The female subject is currently alive and cooperating with the investigation.
